### Typical Inductance vs. Frequency Characteristics:



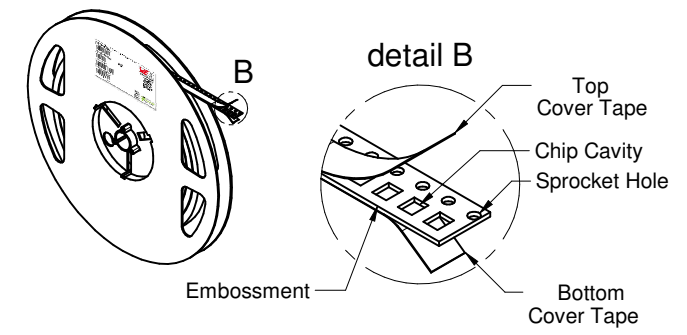
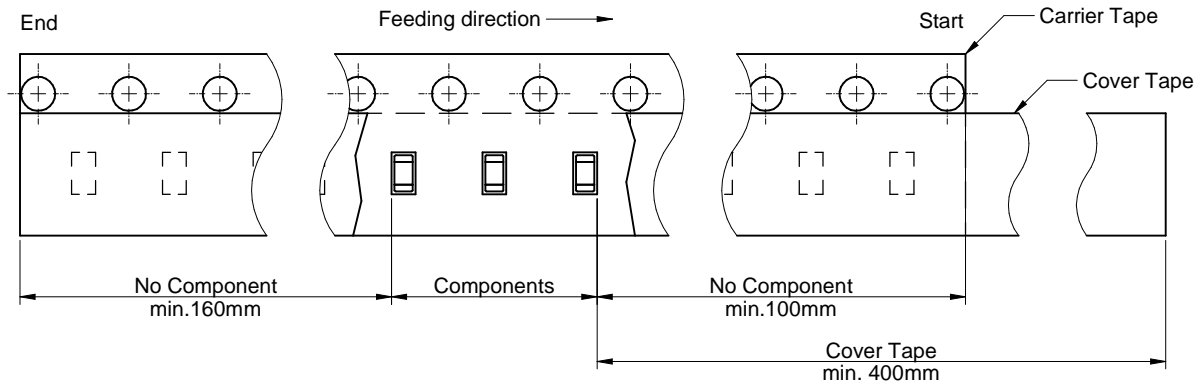
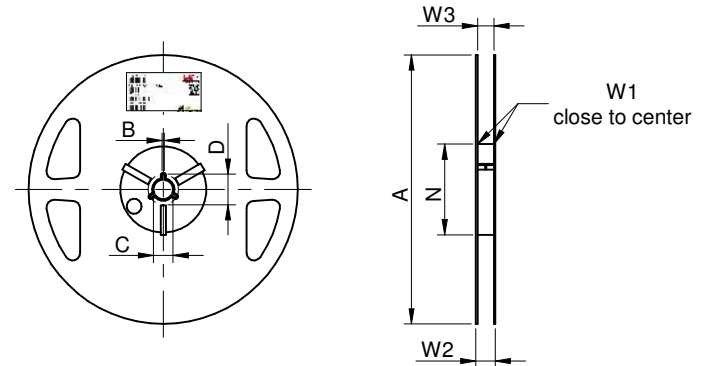
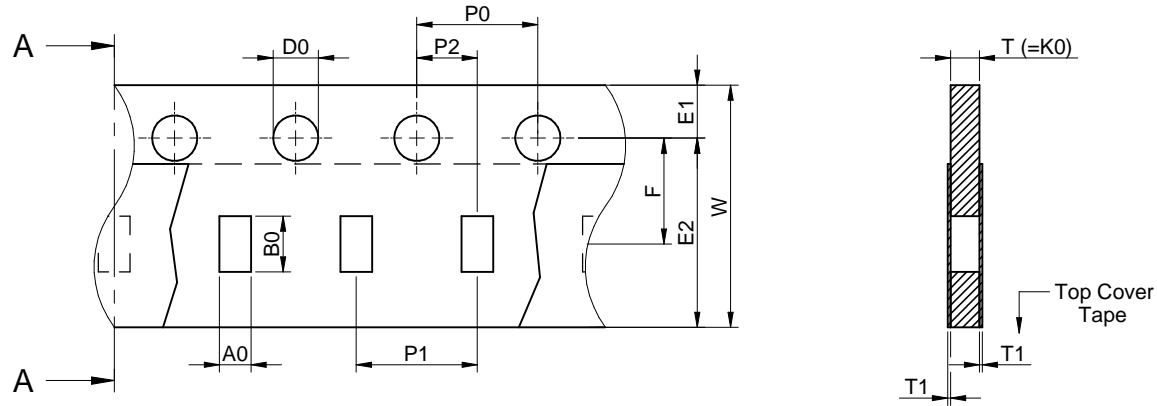



## Packaging:


