




Fig.1 Power Dissipation Derating Curve

Fig.2 Maximum Safe Operating Area





Fig.3 Normalized Transient Thermal Resistance vs. Pulse Width





Fig.7 Breakdown Voltage vs. Junction Temperature





Fig.8 Typical Transfer Characteristics

Fig.9 Gate Threshold Voltage vs. **Junction Temperature**





Fig.10 Forward Transfer Admittance vs. **Drain Current**





Fig.11 Drain Current Derating Curve





Fig.14 Static Drain - Source On - State Resistance vs. Drain Current (I)




Fig.18 Typical Capacitances vs.

Fig.19 Switching Characteristics




Fig.20 Typical Gate Charge





Fig.21 Source Current vs. Source Drain Voltage

Fig.1-1 Switching Time Measurement Circuit




Fig.2-1 Gate Charge Measurement Circuit






Fig.1-2 Switching Waveforms




