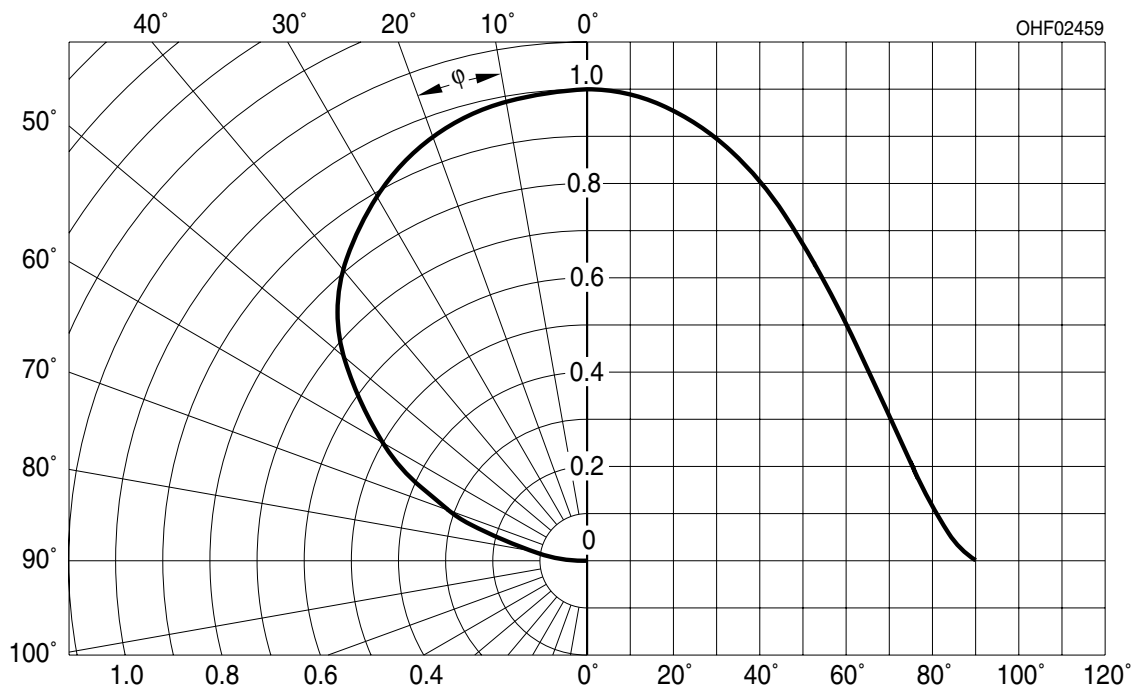

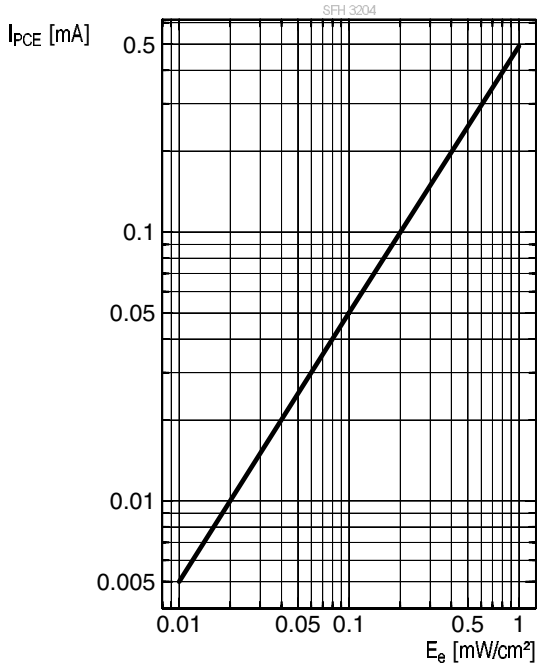

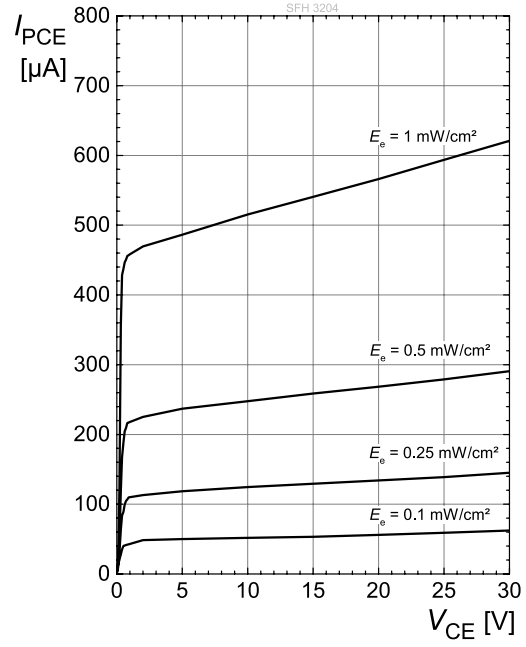

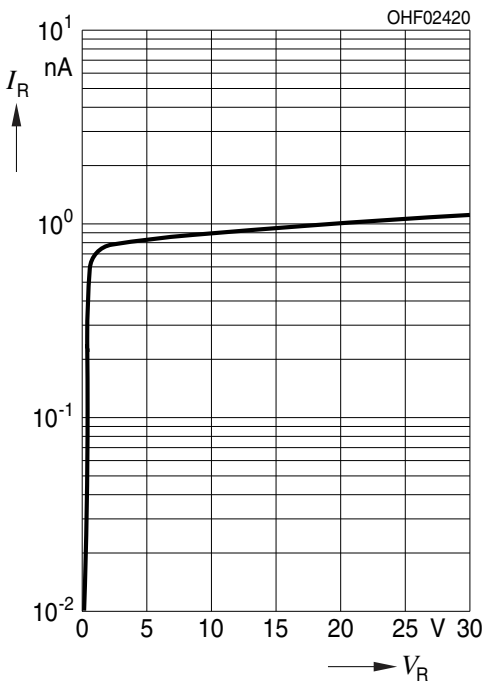

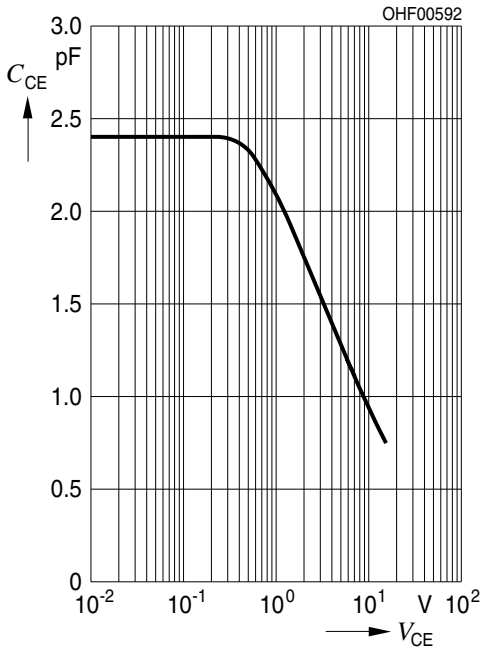

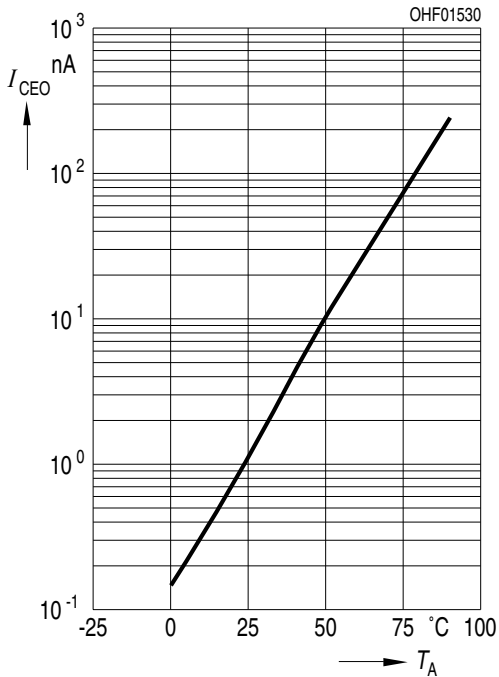

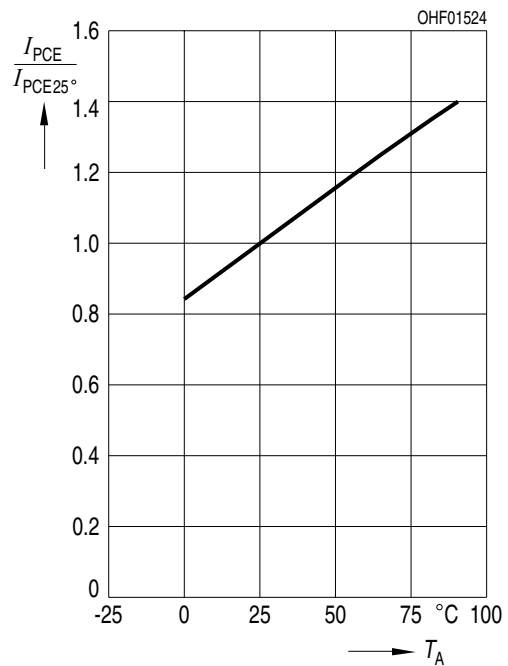

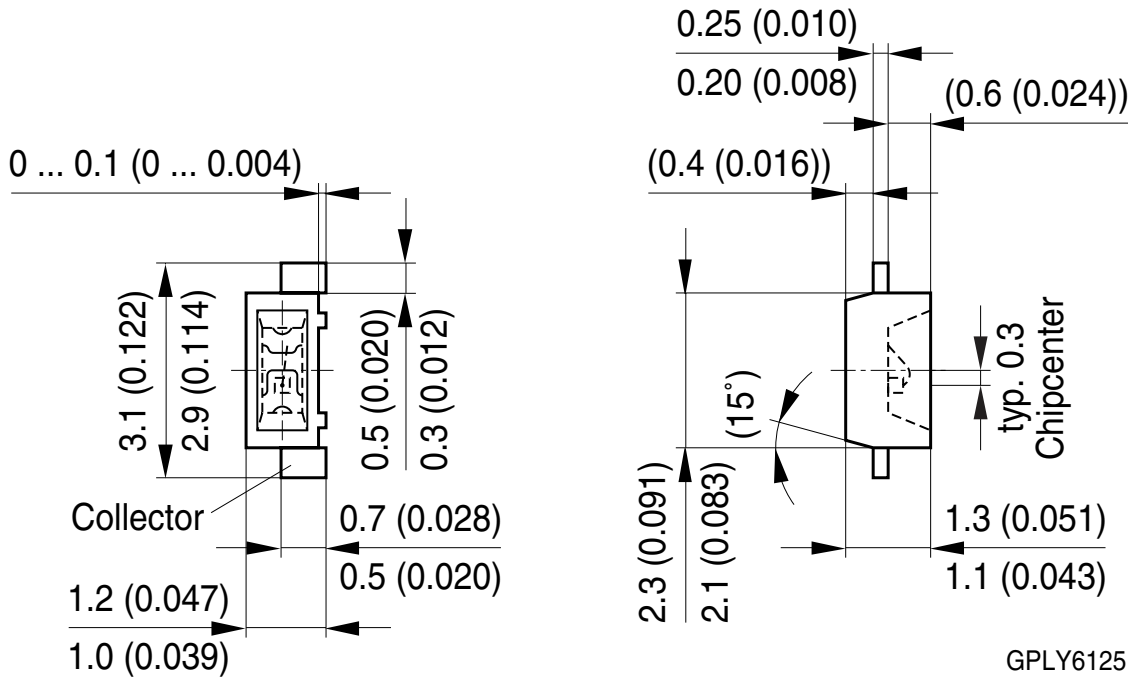

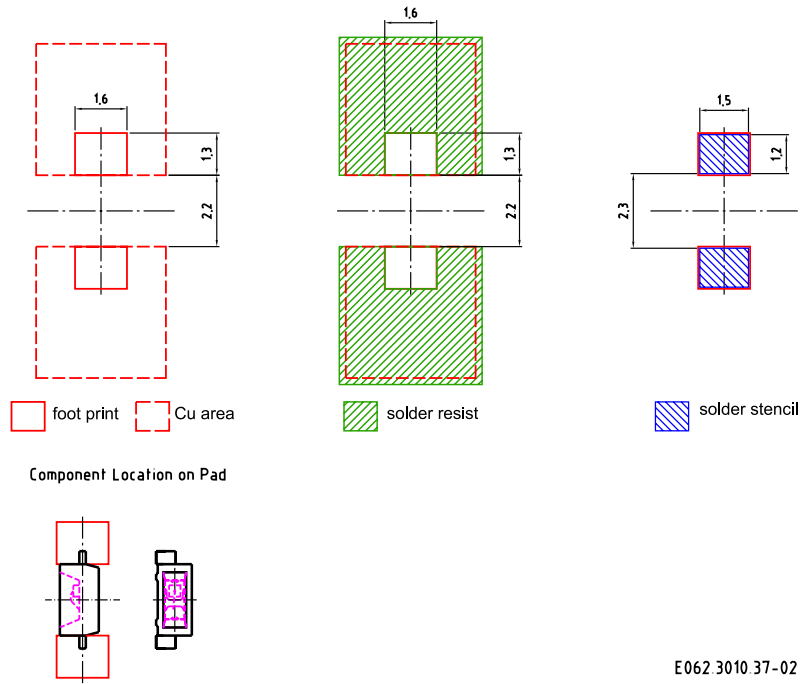
Dimensional Drawing ⁶⁾

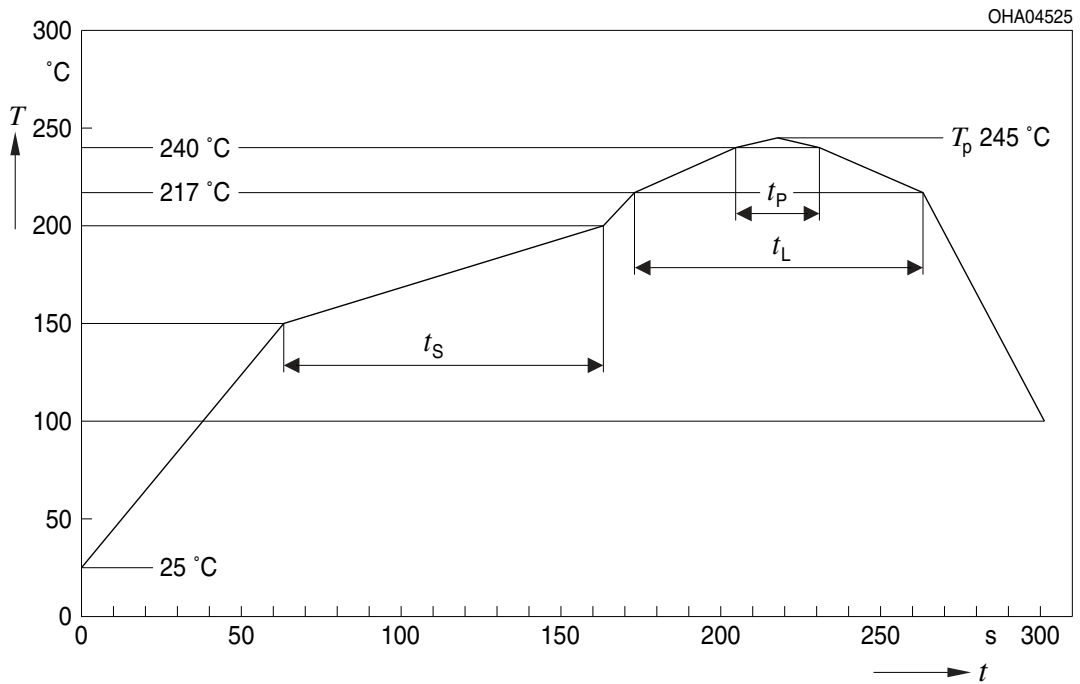

Reflow Soldering Profile

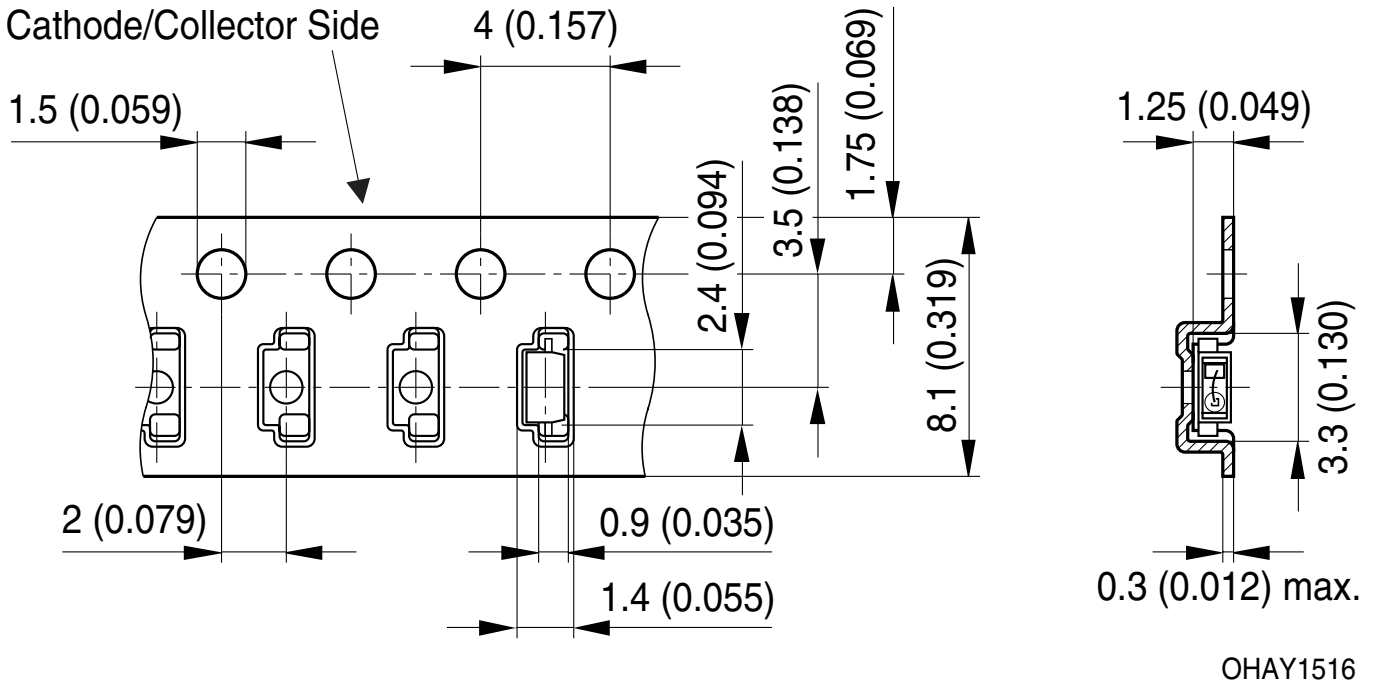

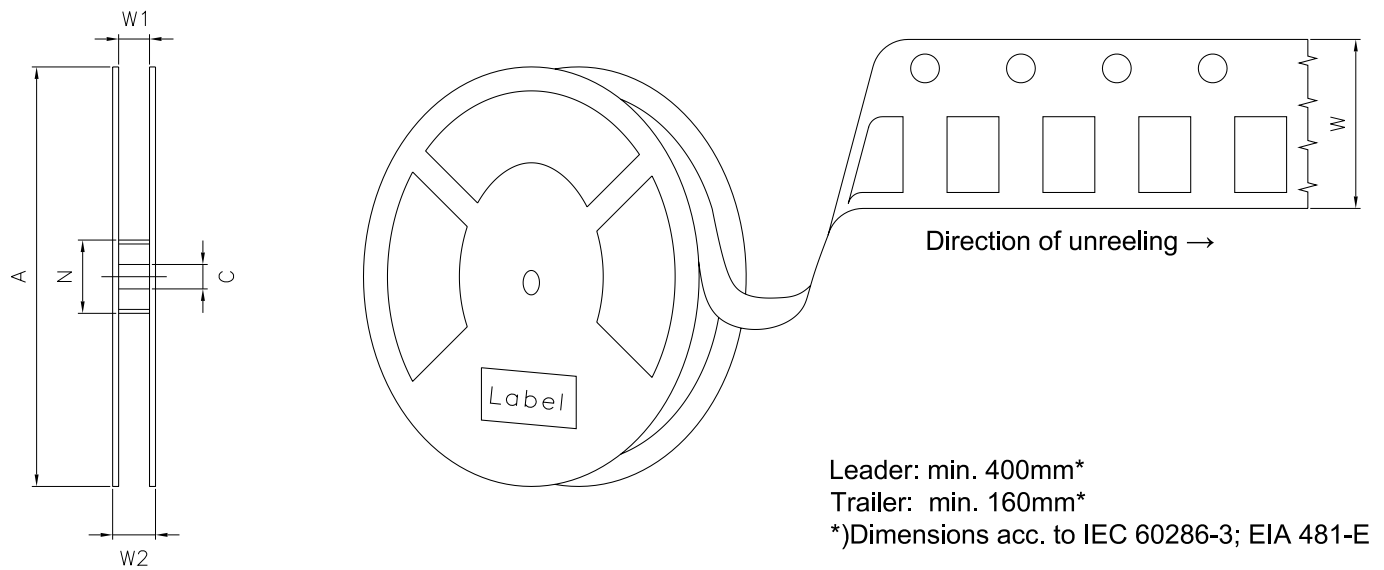

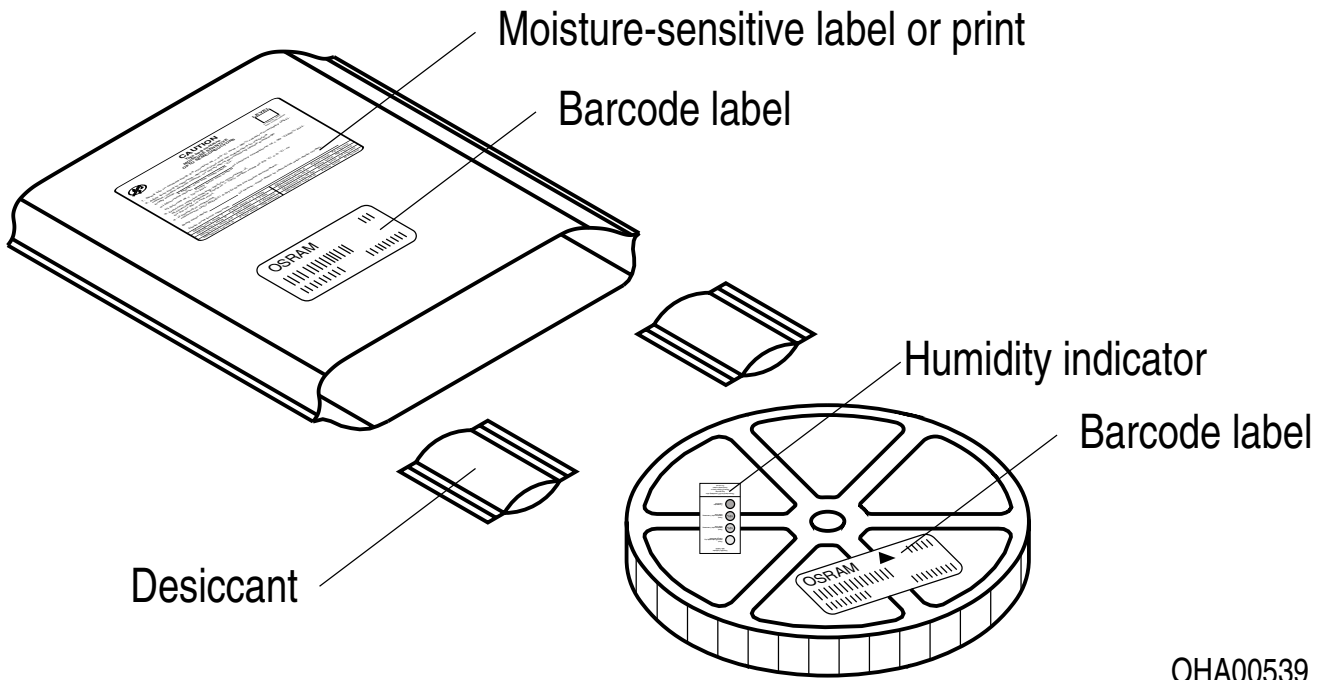

Notes
