


# Fig.1 Ground Emitter Propagation

## Fig.2 Typical Output Characteristics





# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current




# Fig.8 Gain Bandwidth Product vs. Emitter Current






Fig.10 Safe Operating Area
