





Figure 1. Derating Curve

Figure 2.  $I_C$  -  $V_{CE}$ 







Figure 3. DC Current Gain

Figure 4. Collector Saturation Region






Figure 5. On Voltage




Figure 7. Capacitance

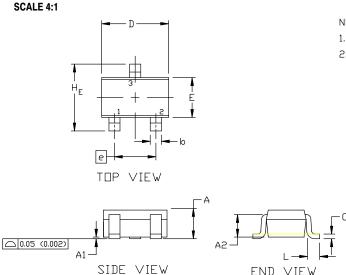

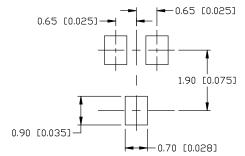
