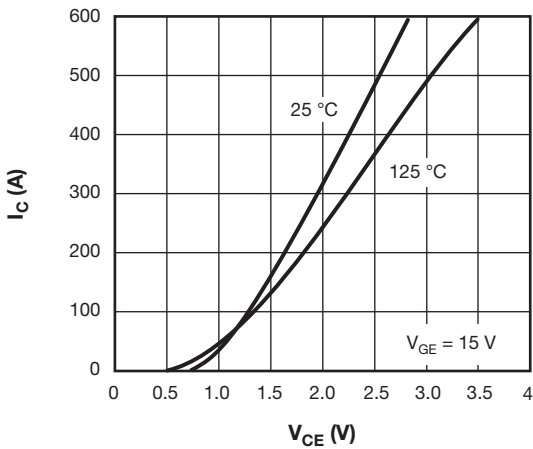


Fig. 1 - IGBT Typical Output Characteristics

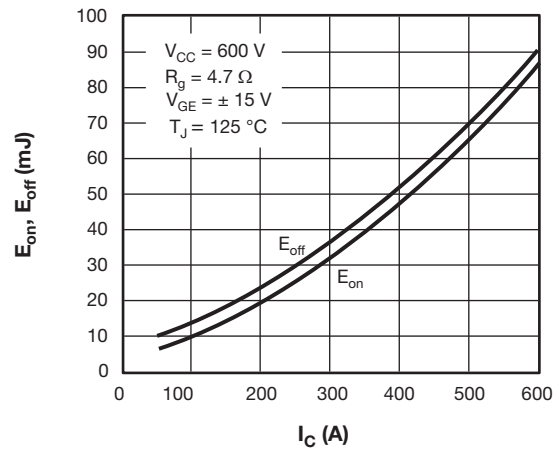


Fig. 3 - IGBT Switching Loss vs. I_C

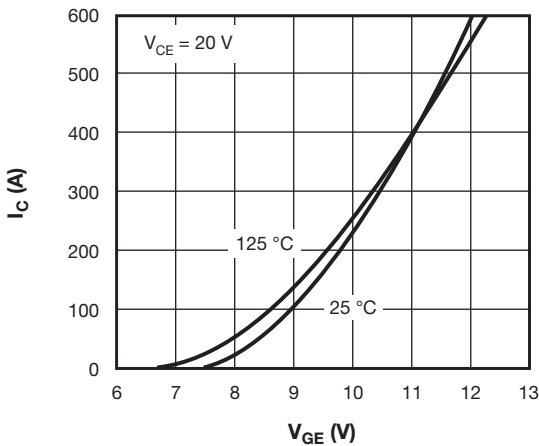


Fig. 2 - IGBT Typical Transfer Characteristics

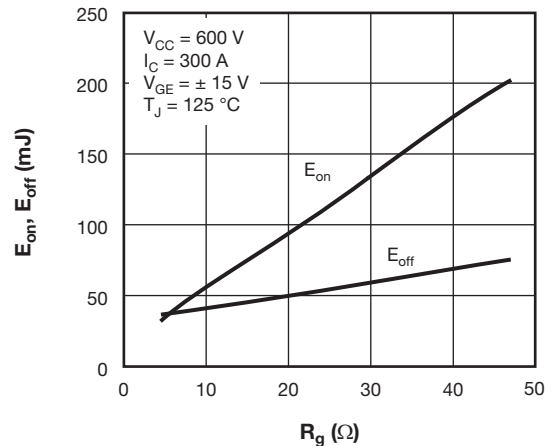
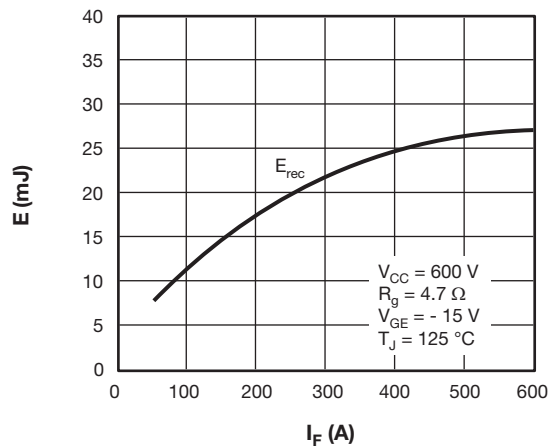
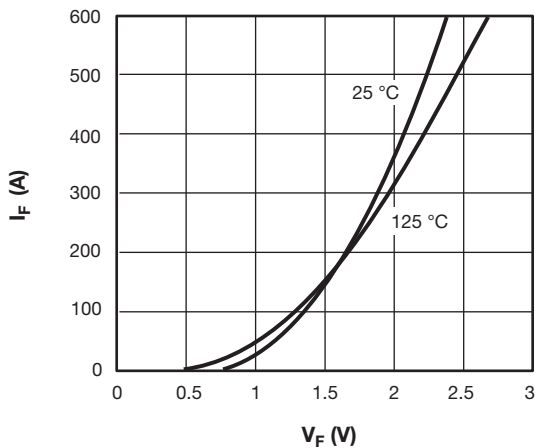
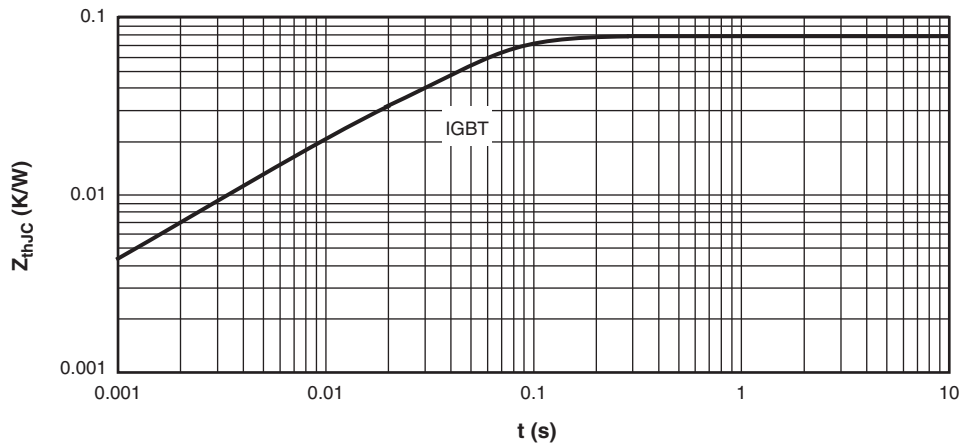
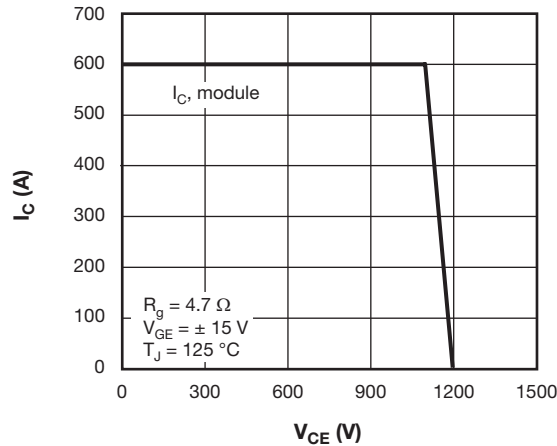


Fig. 4 - IGBT Switching Loss vs. R_g



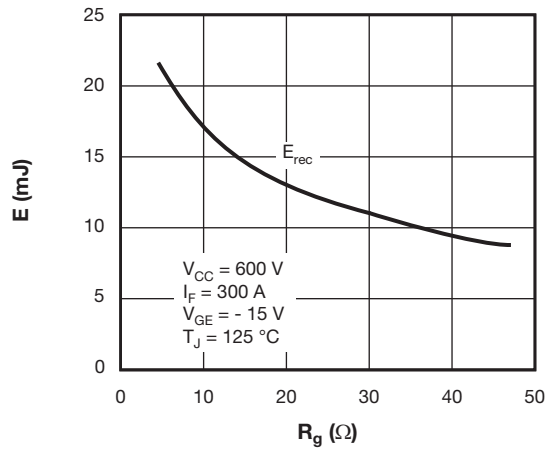


Fig. 9 - Diode Switching Loss vs. Gate Resistance R_g

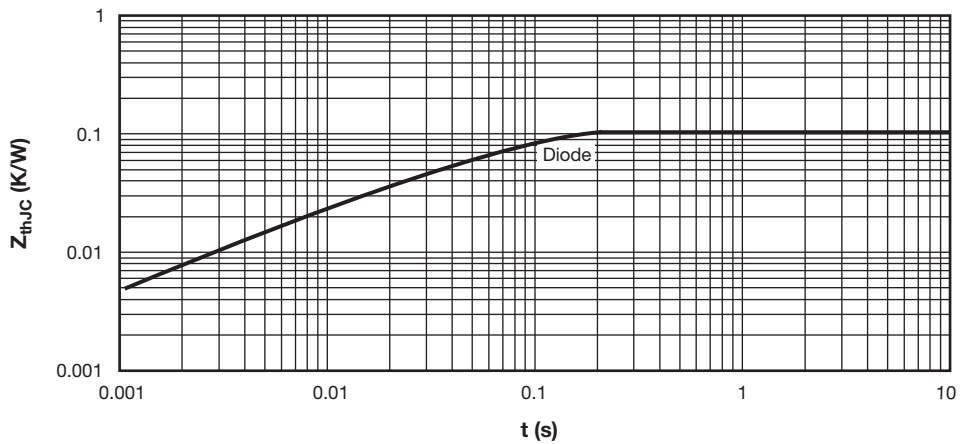
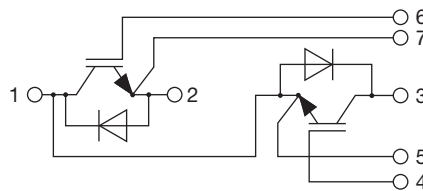


Fig. 10 - Diode Transient Thermal Impedance

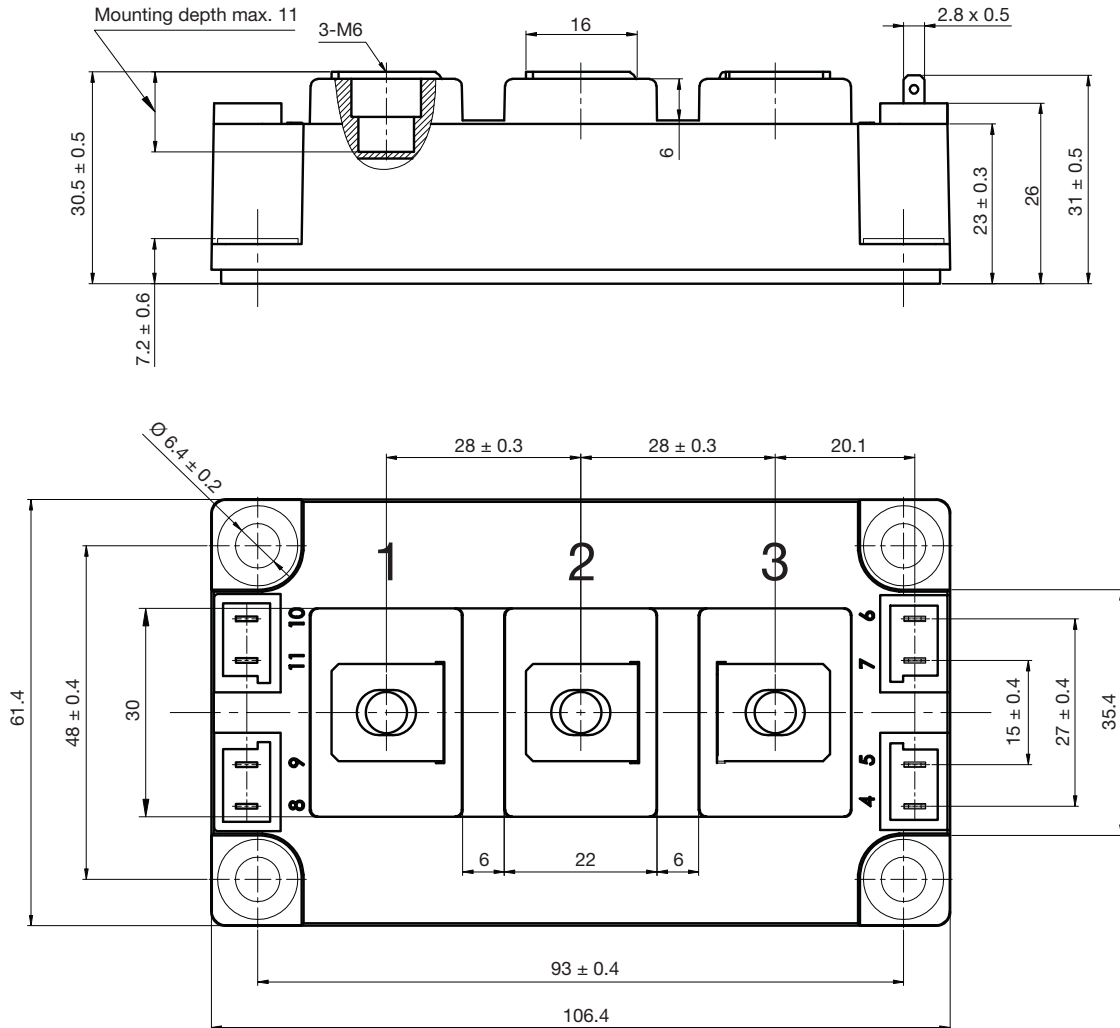
