






## Fig.1 Ground Emitter Propagation Characteristics






## COLLECTOR TO EMITTER VOLTAGE : $V_{CE}$ [V]


# Fig.3 DC Current Gain vs. Collector Current (I)

DC CURRENT GAIN : hFE




COLLECTOR CURRENT : Ic [mA]

# Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current(II)




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current (I)





Fig.8 Gain Bandwith Product vs. Emitter Current




