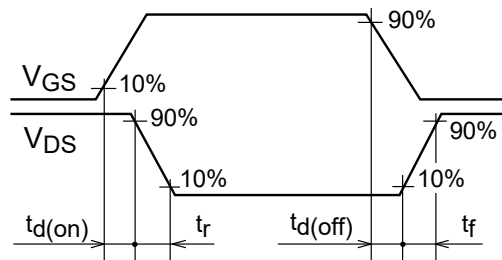


Switching Time
