



PACKAGE DRAWING (Unit: mm)




EQUIVALENT CIRCUIT





TEST CIRCUIT 1 SWITCHING TIME




TEST CIRCUIT 2 GATE CHARGE



TYPICAL CHARACTERISTICS ($T_A = 25^{\circ}C$)




