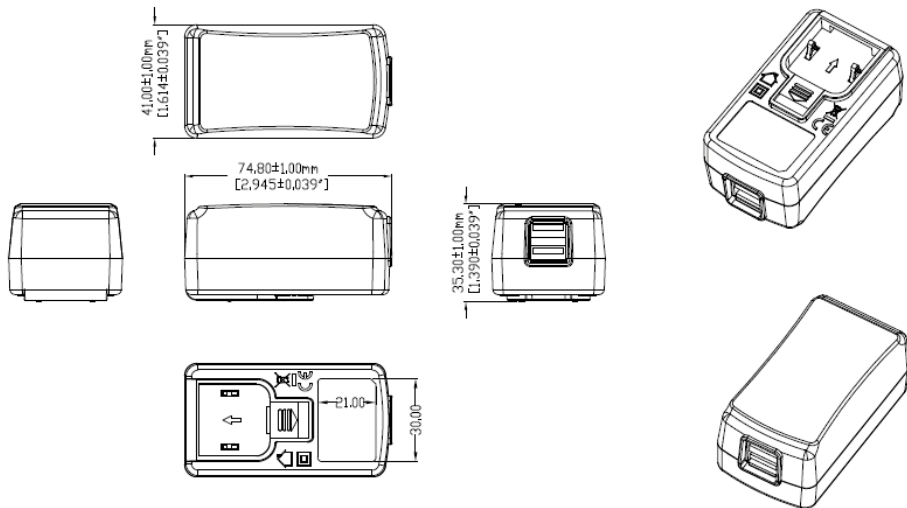

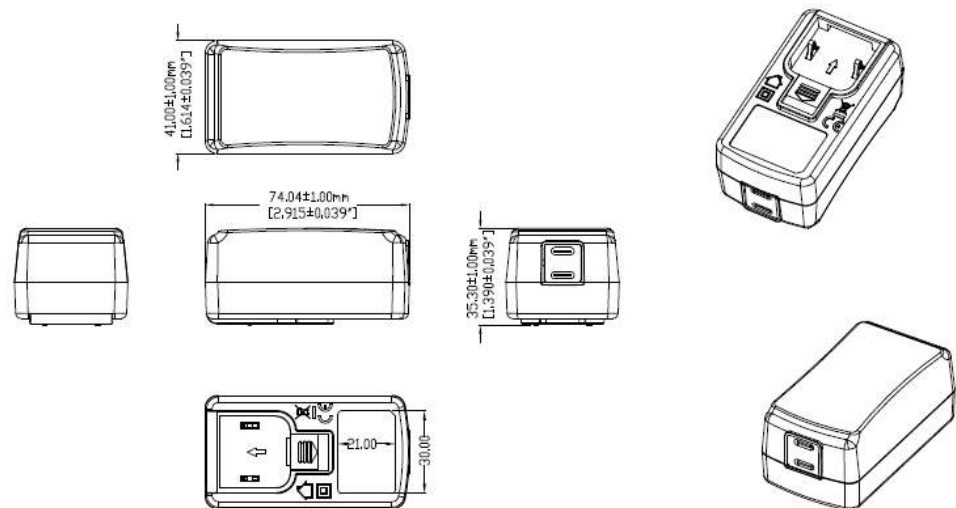

Enclosure for units with 1 USB A and 1 USB C connectors. Part #s are WRxxxxxxUSB1A1C

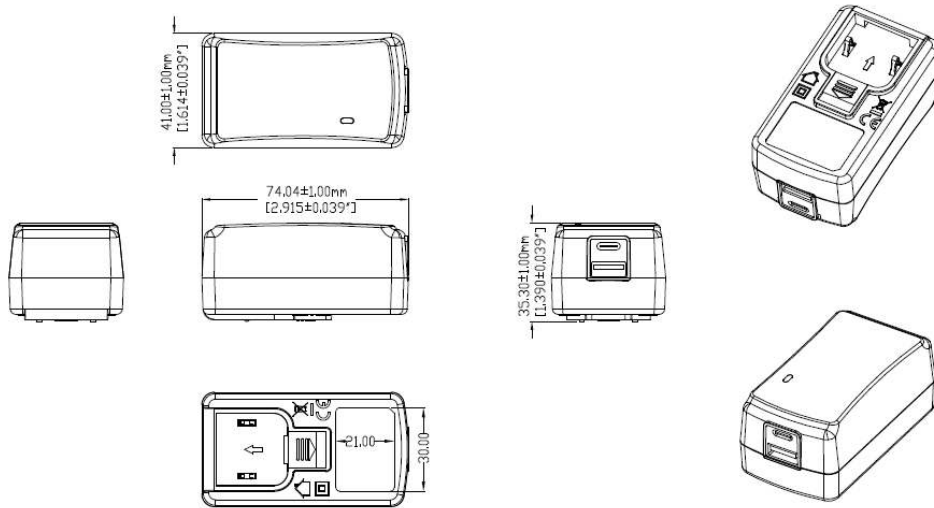

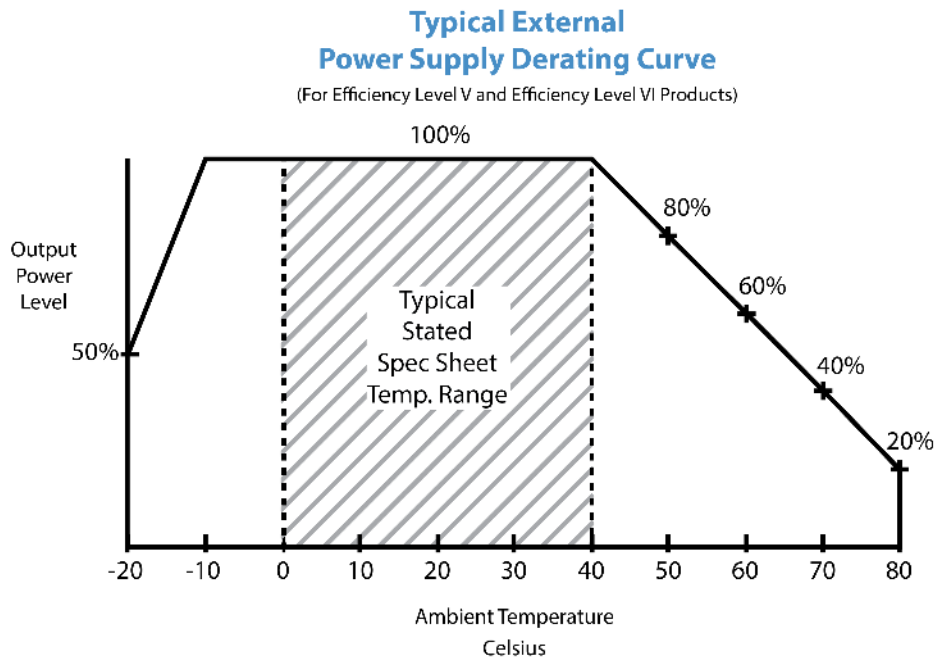
