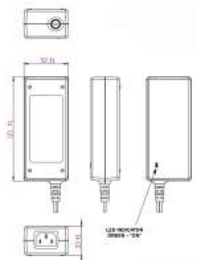

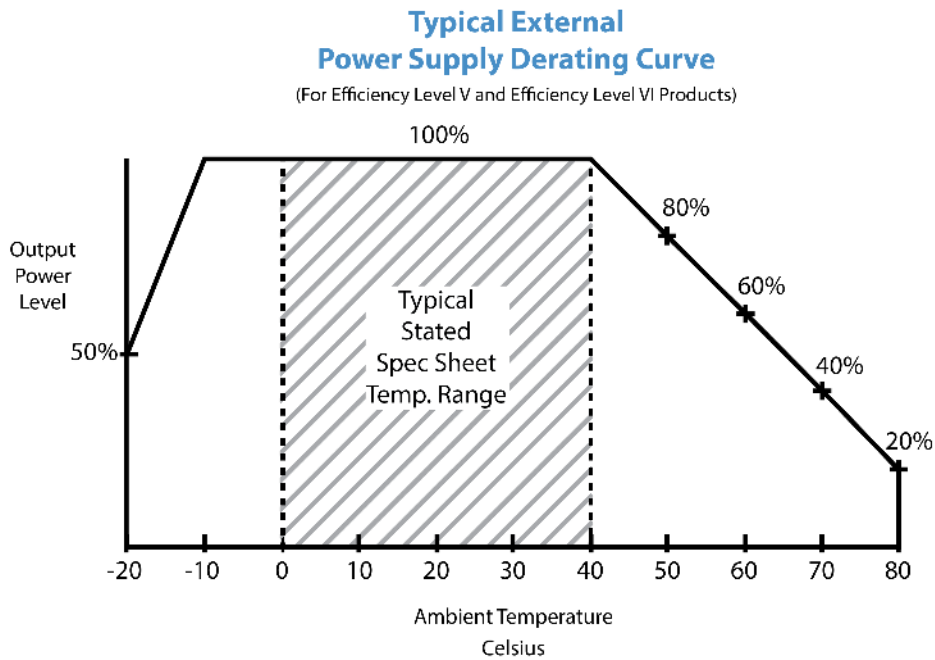

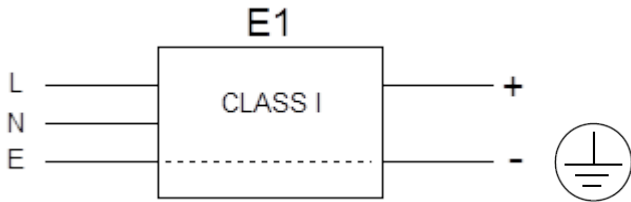
DERATING CURVE
