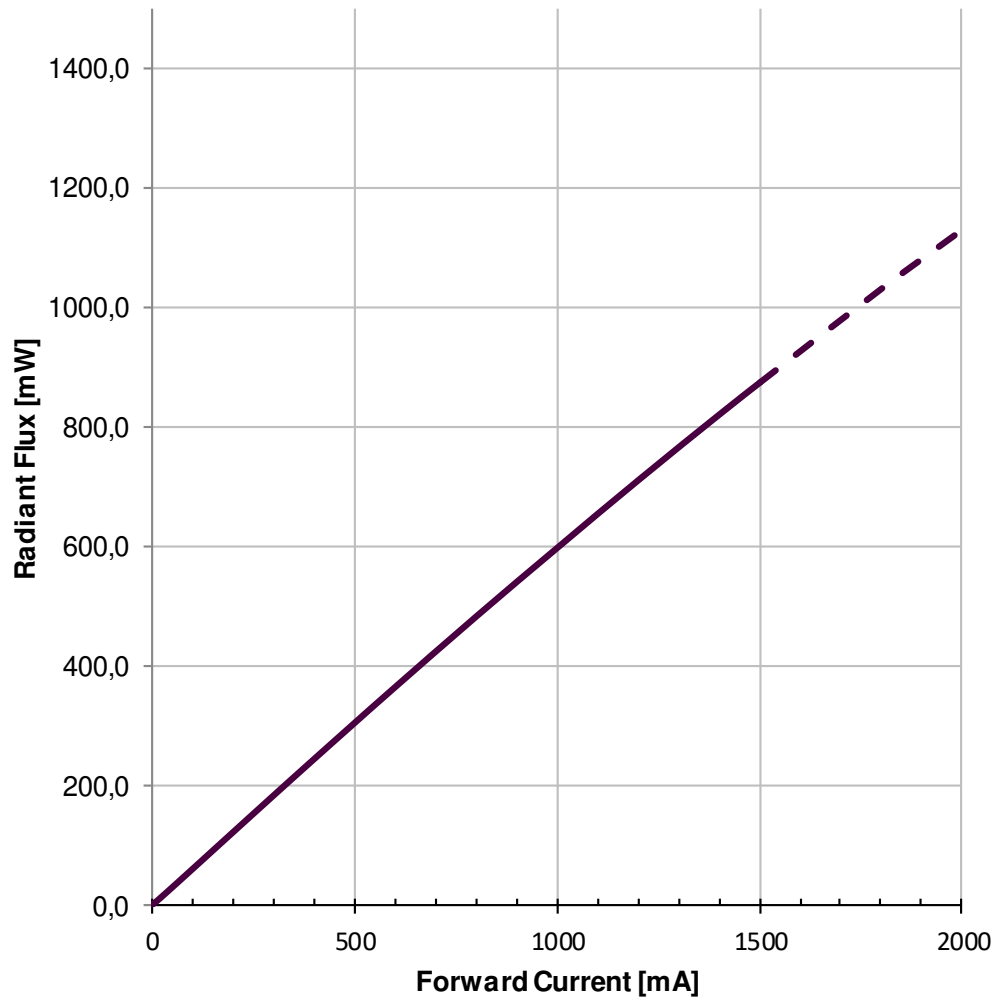
### Forward Current vs. Forward Voltage:



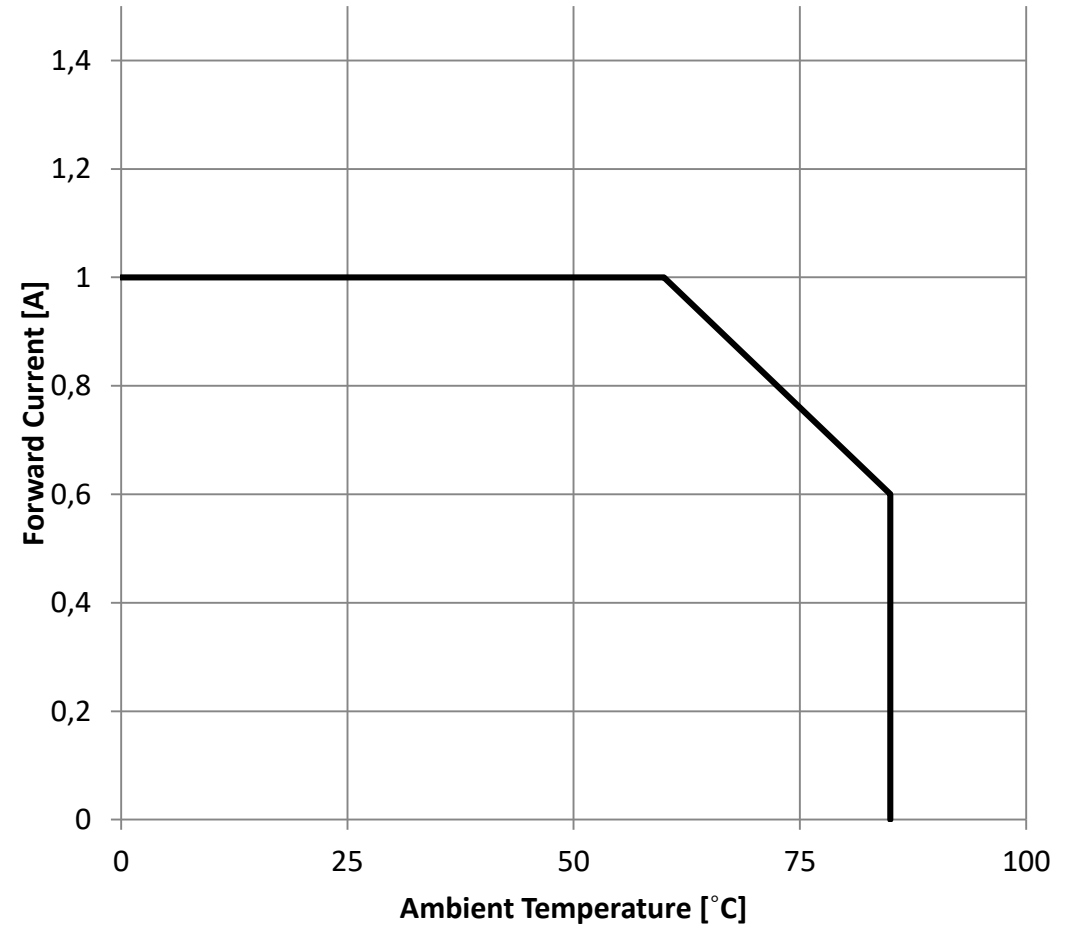

### Radiant Flux vs. Forward Current:



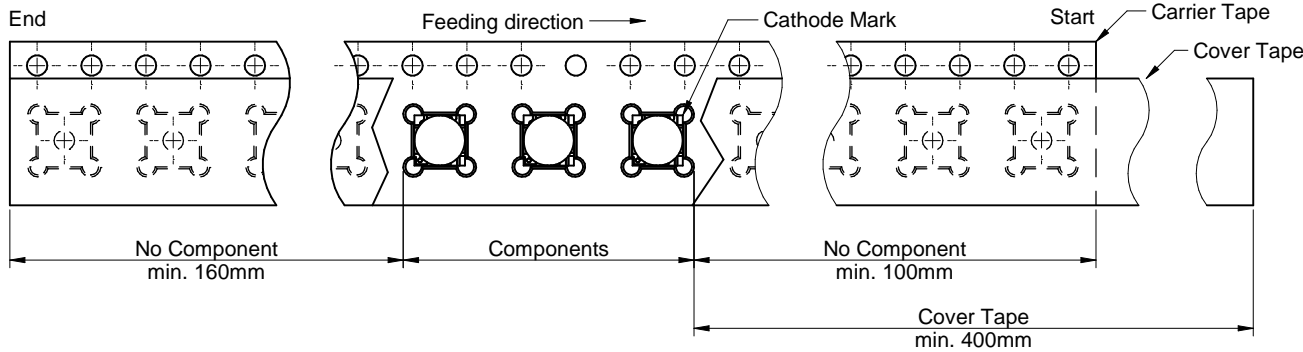
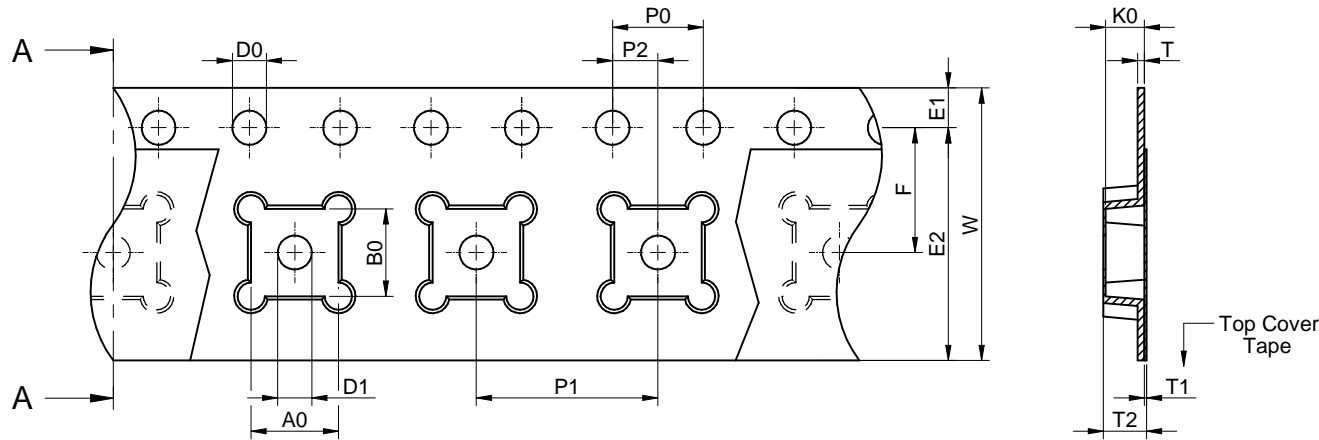

#### Soldering:






