


Figure 1. Forward Current Derating Curve




Figure 2. Maximum Non-Repetitive Peak Forward Surge Current




Figure 3. Typical Reverse Characteristic




Figure 4. Typical Instantaneous Forward Characteristics




Figure 5. Typical Forward Characteristics





Figure 6. Typical Junction Capacitance
