

#### Description

CPC1964G is an AC Solid State Switch utilizing dual power SCR outputs. This device also includes zero-cross turn-on circuitry and is specified with a blocking voltage of  $800V_{\rm P}$ .

In addition, the tightly controlled zero-cross circuitry ensures low noise switching of AC loads by minimizing the generation of transients. The optically coupled input and output circuits provide  $2500V_{rms}$  of isolation between the control and load circuits. As a result, the CPC1964G is well suited for industrial environments where electromagnetic interference would disrupt the operation of plant facility communication and control systems.



First Zero-Cross Turn-On Voltage






#### **Board Wash**


IXYS Integrated Circuits Division recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since IXYS Integrated Circuits Division employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.
