### Typical Impedance vs. Frequency:



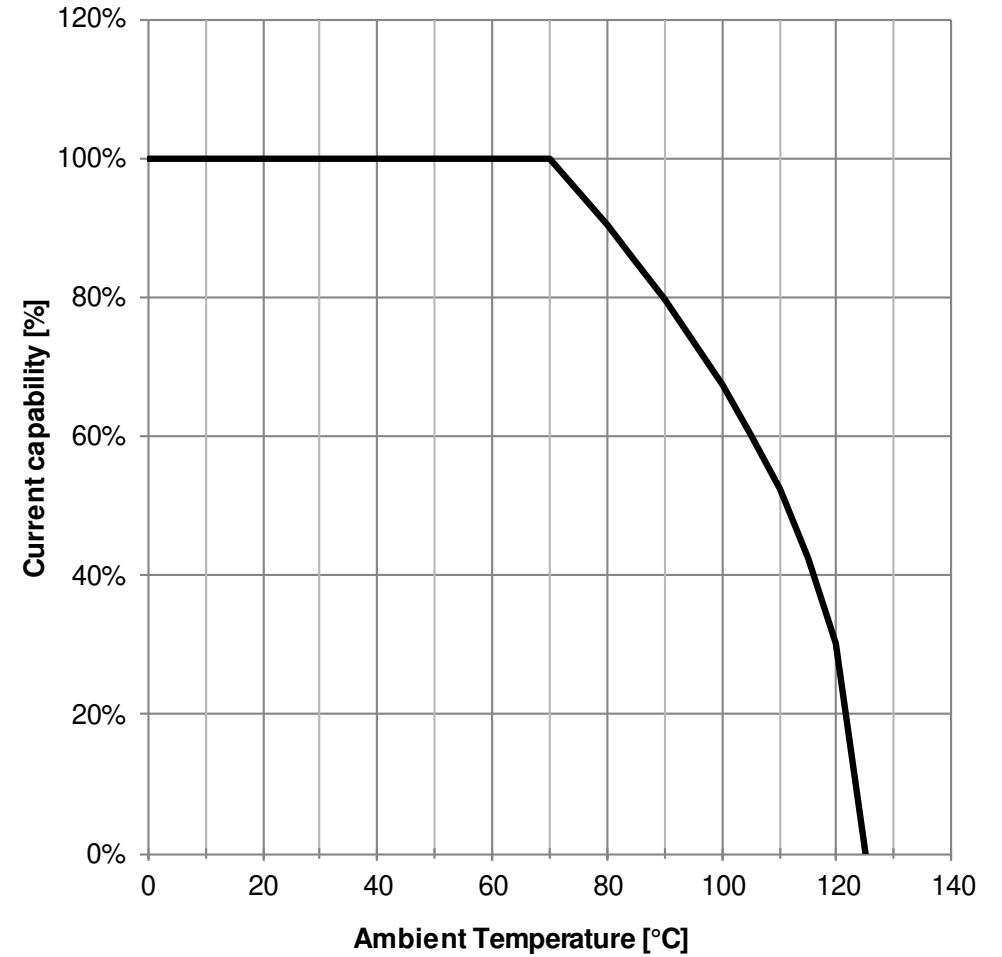

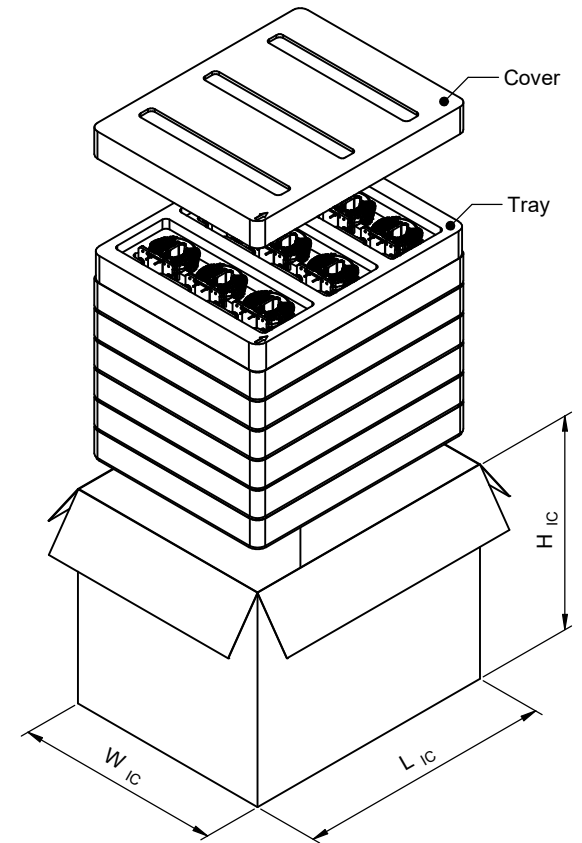
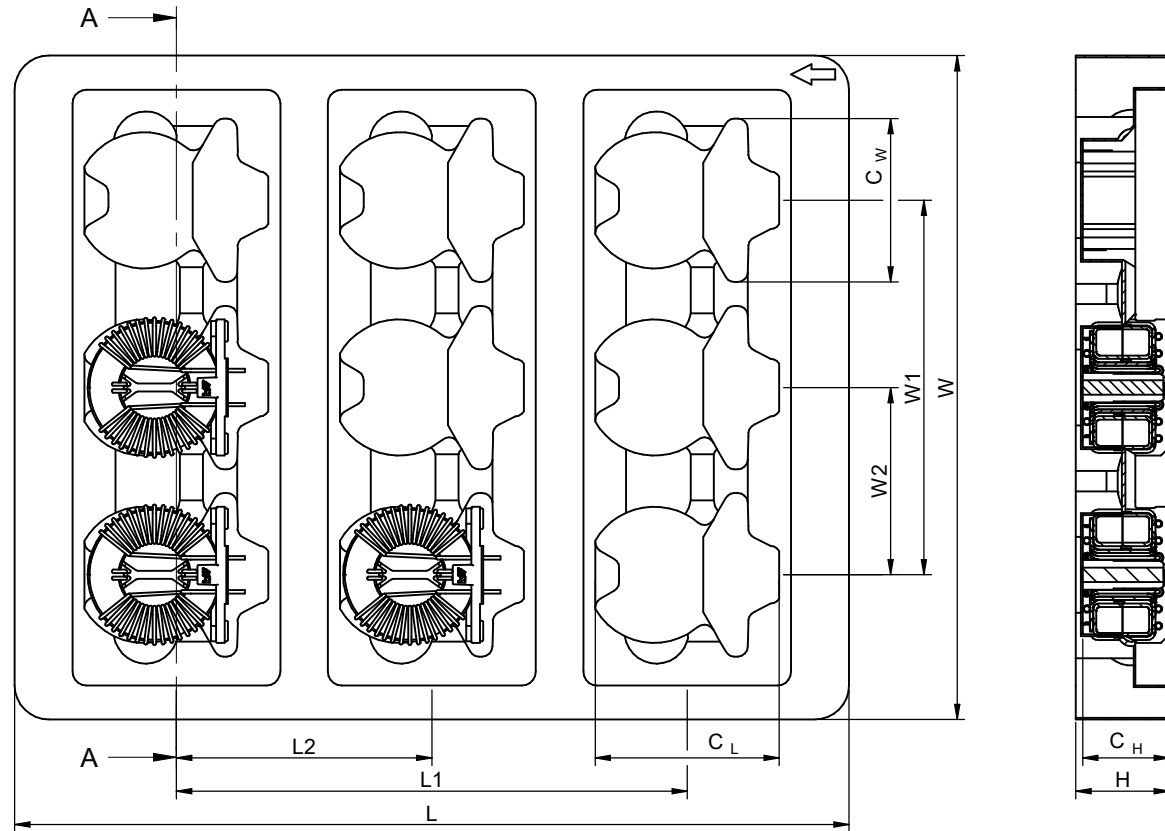


## Derating Curve:

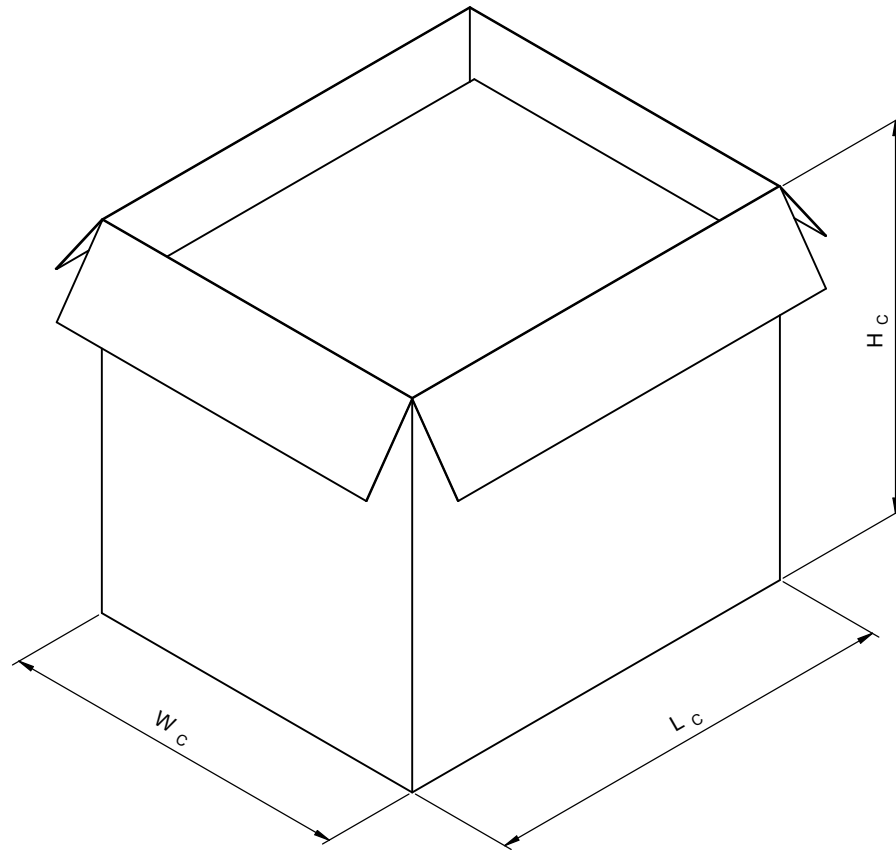





## Packaging:


