In the automotive industry they can be used in air bag deployment and in the instrument cluster. The high current gain allows e<sup>2</sup>PowerEdge devices to be driven directly from PMU's control outputs, and the Linear Gain (Beta) makes them ideal components in analog amplifiers.






Figure 1. V<sub>CE</sub> versus I<sub>b</sub>




Figure 2. V<sub>CE</sub> versus I<sub>c</sub>




Figure 3. h<sub>FE</sub> versus I<sub>c</sub>




Figure 4. V<sub>BE(on)</sub> versus I<sub>c</sub>




Figure 5. V<sub>BE(sat)</sub> versus I<sub>c</sub>




Figure 6. Safe Operating Area




Figure 7. Normalized Thermal Response

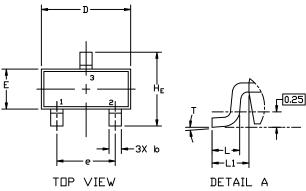




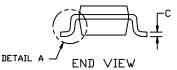


