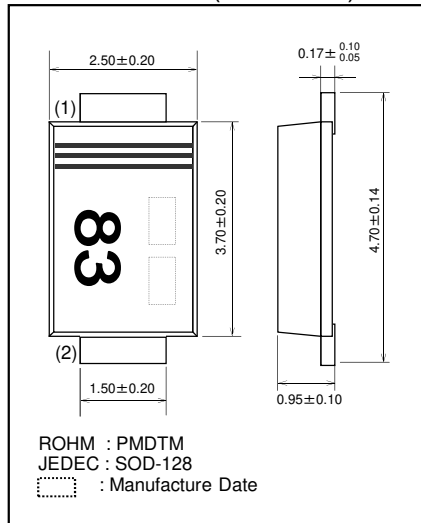

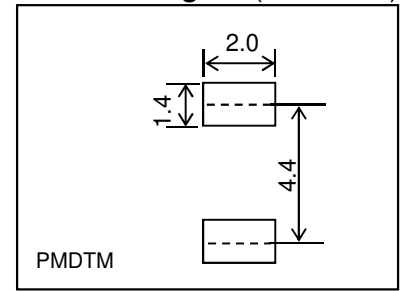

Silicon epitaxial planar type

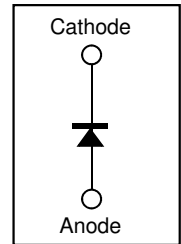

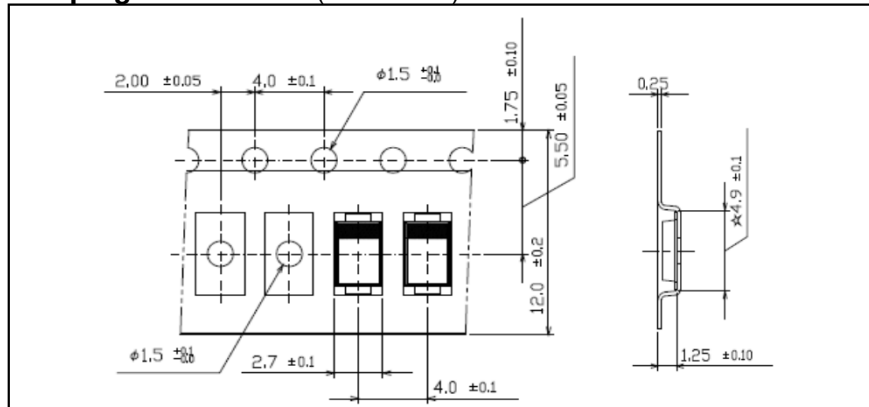
●Land Size Figure (Unit : mm)

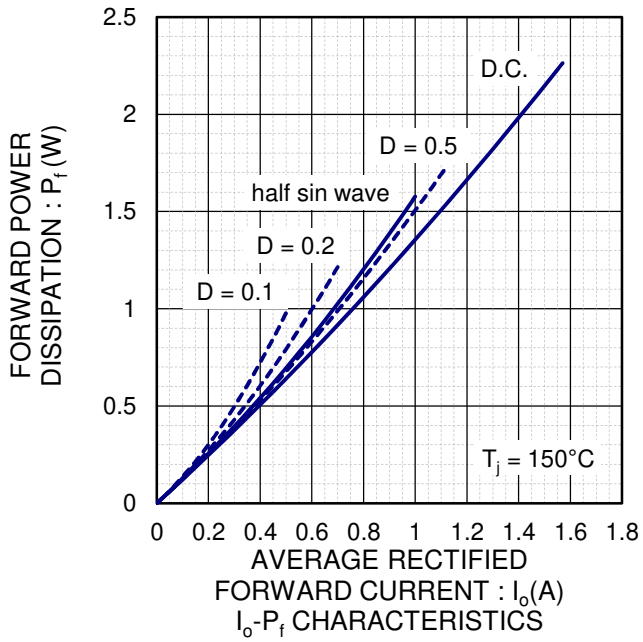
●Electrical Characteristic Curves

## Precaution for Mounting / Circuit board design

2. In principle, the reflow soldering method must be used on a surface-mount products, the flow soldering method must be used on a through hole mount products. If the flow soldering method is preferred on a surface-mount products, please consult with the ROHM representative in advance.
