

#### Fig.1 Grounded Emitter Propagation Characteristics


## Fig.2 Typical Output Characteristics




COLLECTOR TO EMITTER VOLTAGE : V<sub>CE</sub> [V]

### Fig.4 DC Current Gain vs. Collector Current(II)














# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current




Fig.10 Safe Operating Area


Fig.9 Emitter input capacitance vs. Emitter
