### Typical Impedance Characteristics:



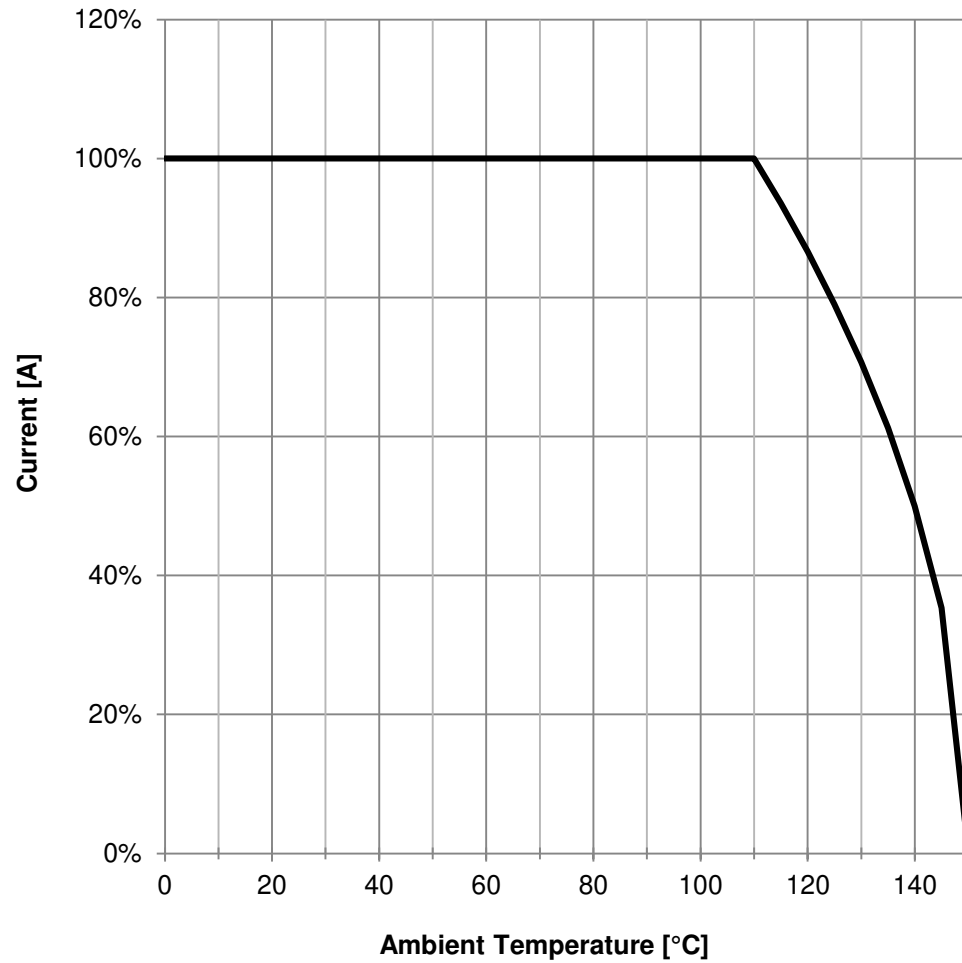
### Typical Inductance vs. Current Characteristics:









#### Packaging:


