1. Product profile

1.1 General description

The BB199 is a low voltage variable capacitance diode for the Voltage Controlled Oscillator (VCO) and Voltage Controlled Crystal Oscillator (VCXO) applications.








Fig 6. Package outline SOD523 (SC-79)
