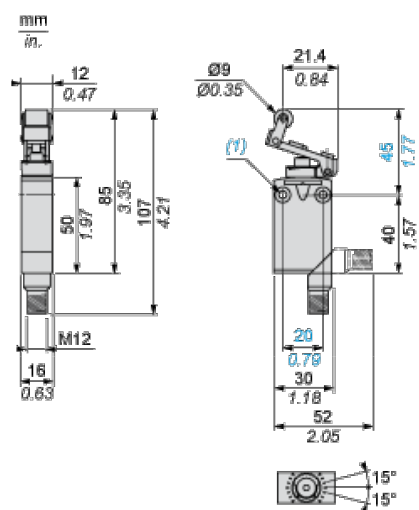

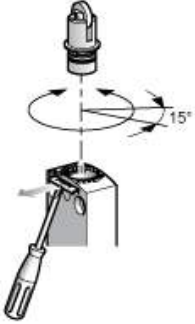

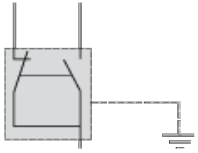

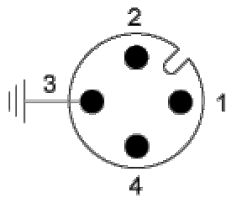
Wiring Diagram

Wiring Diagram

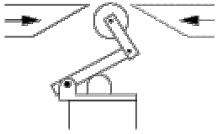
4-pin, M12, 3A-250V



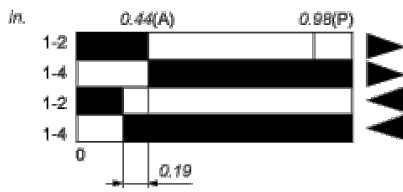
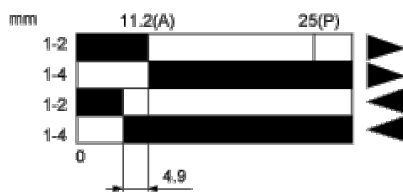
