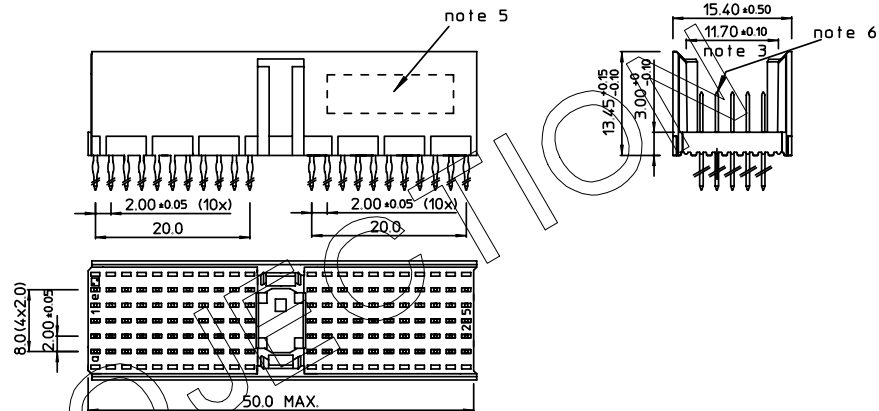

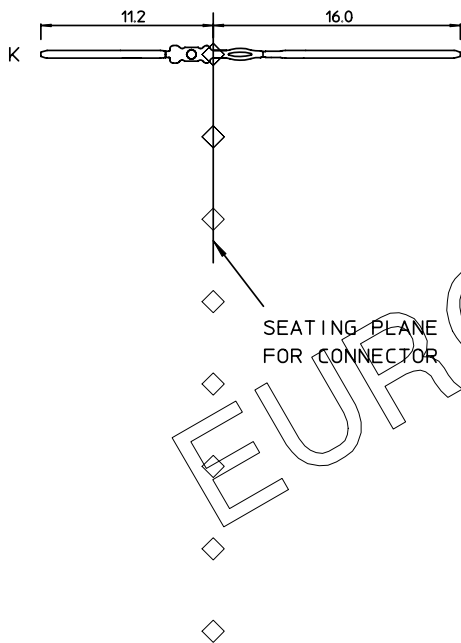

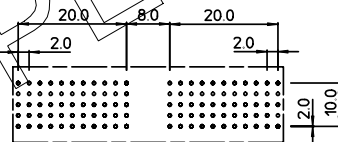
LOADED CONNECTOR ASSEMBLY (FOR EXAMPLE)
