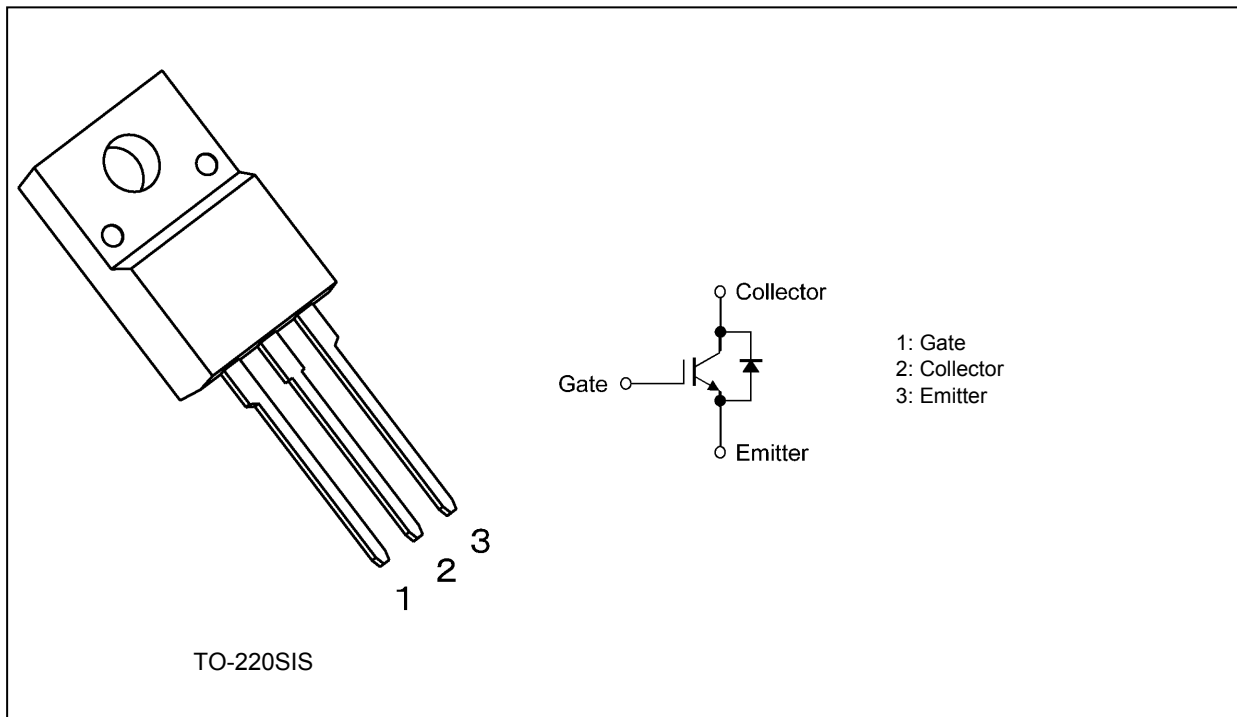

In case that the temperature rise due to loss of IGBT exceeds the heat release capacity of a device, it leads to thermorunaway and results in destruction.

Therefore, please design heat release of a device with due consideration to the temperature rise of IGBT.

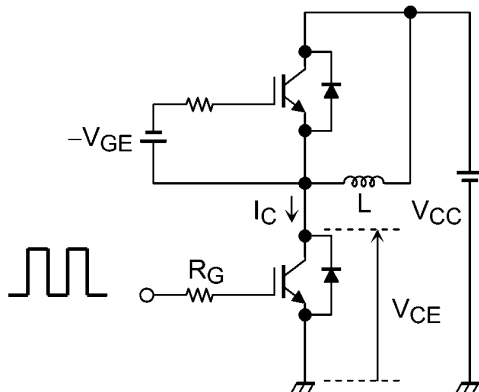


Fig. 6.2.1 Test Circuit of Switching Time

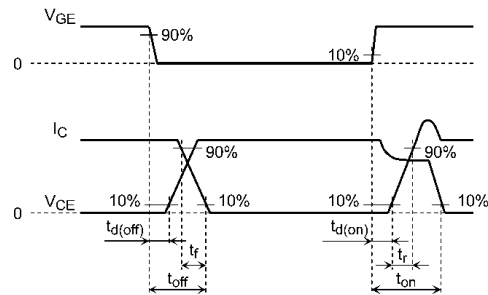


Fig. 6.2.2 Timing Chart of Switching Time

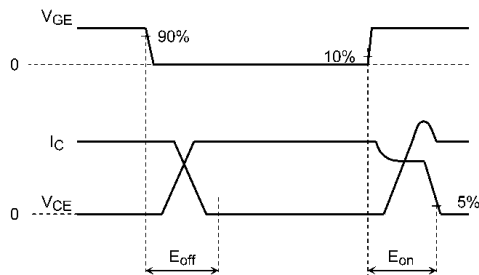
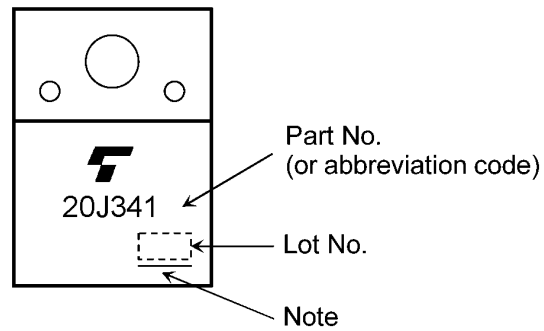


Fig. 6.2.3 Timing Chart of Switching Loss

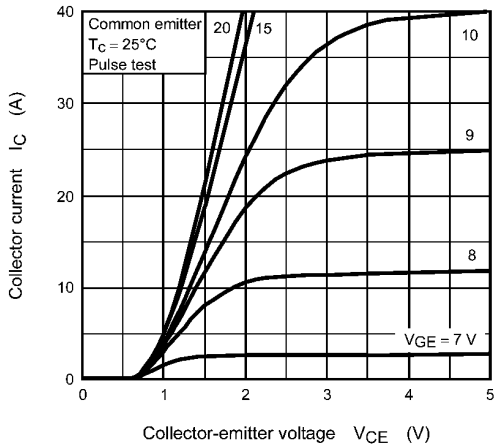


Fig. 8.1 $I_C - V_{CE}$

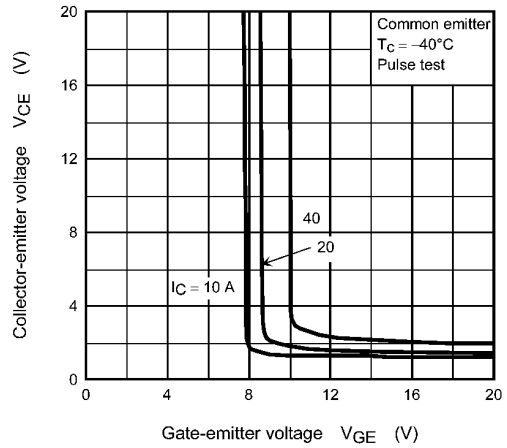


Fig. 8.2 $V_{CE} - V_{GE}$

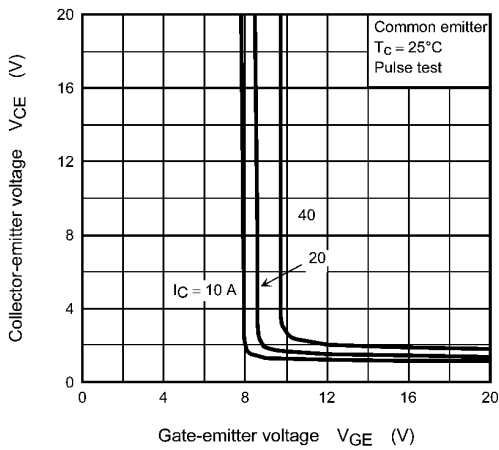


Fig. 8.3 $V_{CE} - V_{GE}$

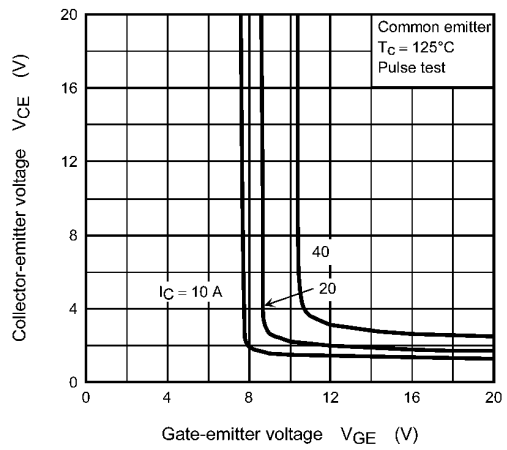


Fig. 8.4 $V_{CE} - V_{GE}$

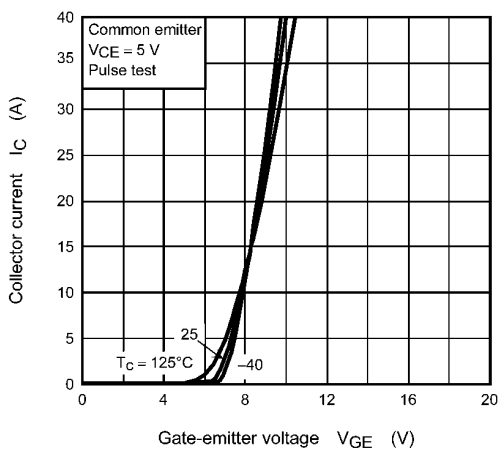


Fig. 8.5 $I_C - V_{GE}$

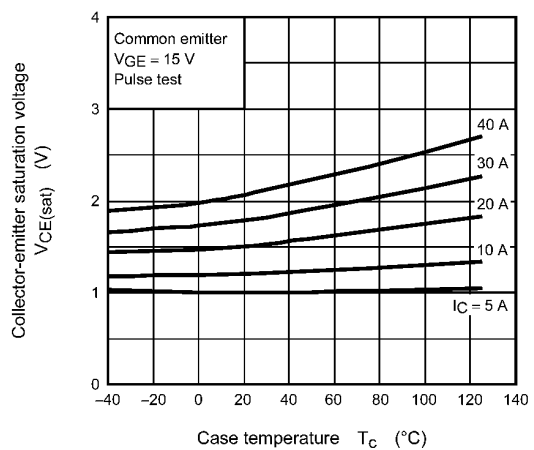


Fig. 8.6 $V_{CE(\text{sat})} - T_c$

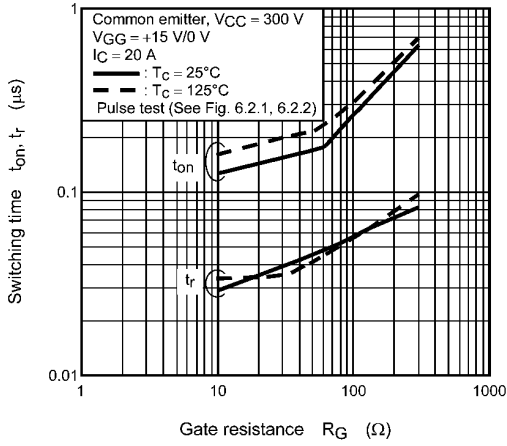


Fig. 8.7 $t_{on}, t_r - R_G$

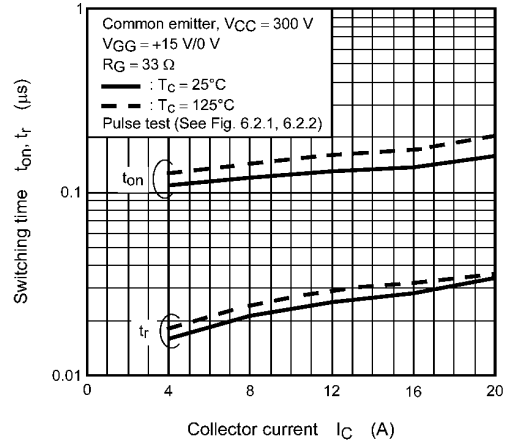


Fig. 8.8 $t_{on}, t_r - I_C$

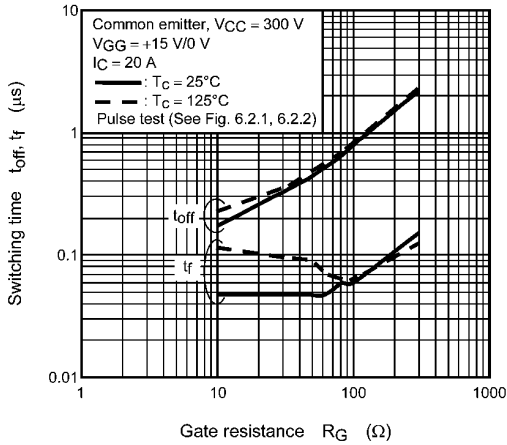


Fig. 8.9 $t_{off}, t_r - R_G$

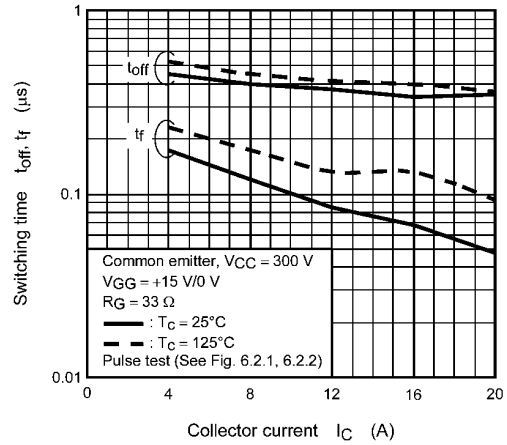


Fig. 8.10 $t_{off}, t_r, t_{d(off)} - I_C$

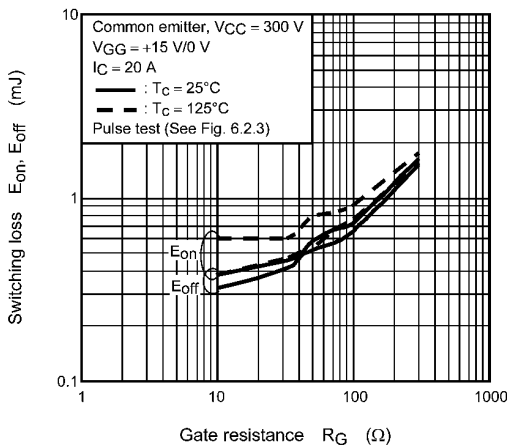


Fig. 8.11 $E_{on}, E_{off} - R_G$

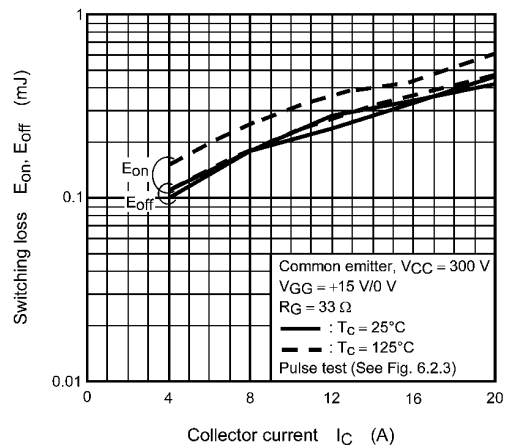


Fig. 8.12 $E_{on}, E_{off} - I_C$

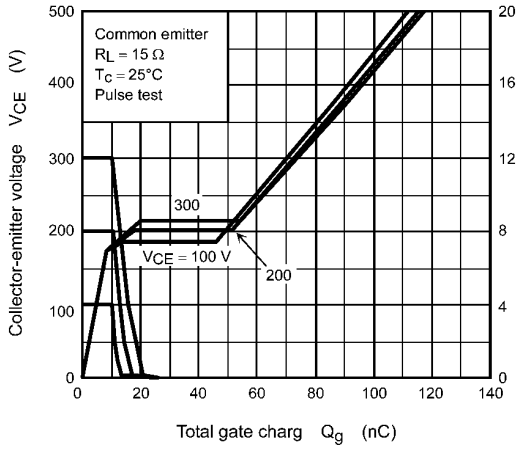


Fig. 8.13 $V_{CE}, V_{GE} - Q_g$

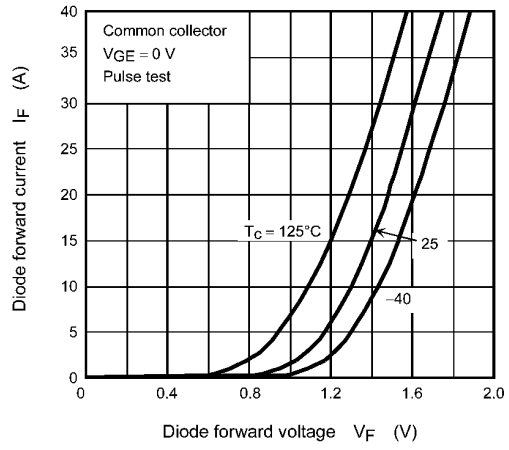


Fig. 8.14 $I_F - V_F$

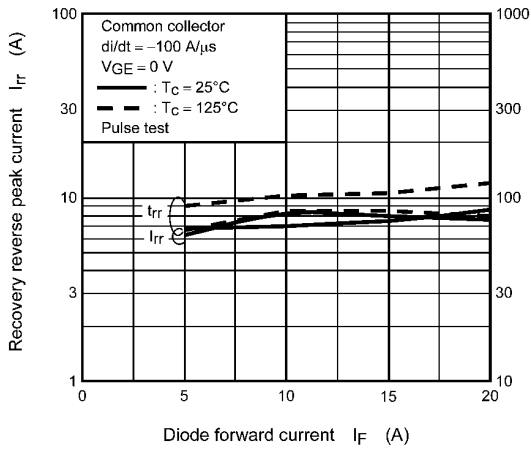


Fig. 8.15 $I_{rr}, t_{rr} - I_F$

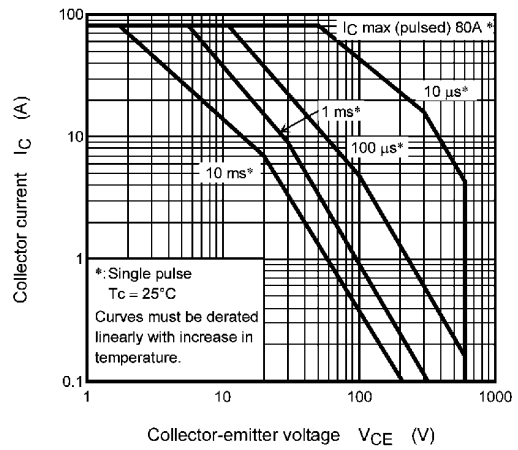


Fig. 8.16 Safe Operating Area (Guaranteed Maximum)

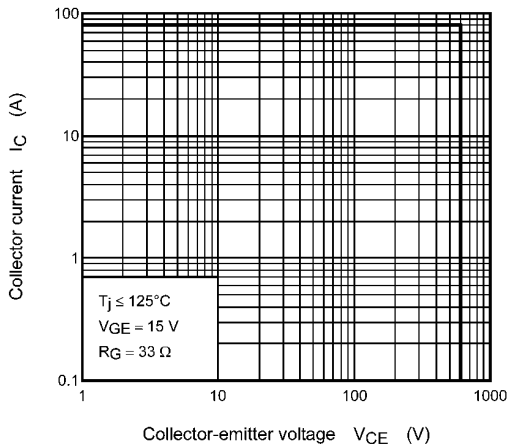


Fig. 8.17 Reverse Bias SOA (Guaranteed Maximum)

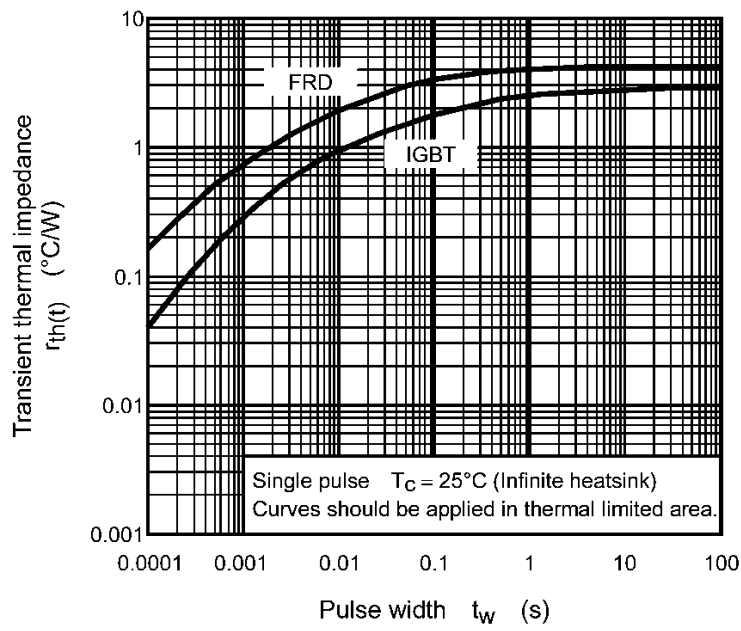


Fig. 8.18 $r_{th}(t) - t_w$
