

#### ILLUSTRATION OF THE TEST CIRCUIT ASSEMBLED ON EVALUATION BOARD
















INPUT-OUTPUT1 INPUT RETURN LOSS vs. FREQUENCY




INPUT-OUTPUT1 OUTPUT RETURN LOSS vs. FREQUENCY




INPUT-OUTPUT2 ISORATION vs. FREQUENCY



INPUT-OUTPUT2 INPUT RETURN LOSS vs. FREQUENCY




INPUT-OUTPUT2 OUTPUT RETURN LOSS vs. FREQUENCY


