### Typical Insertion Loss:



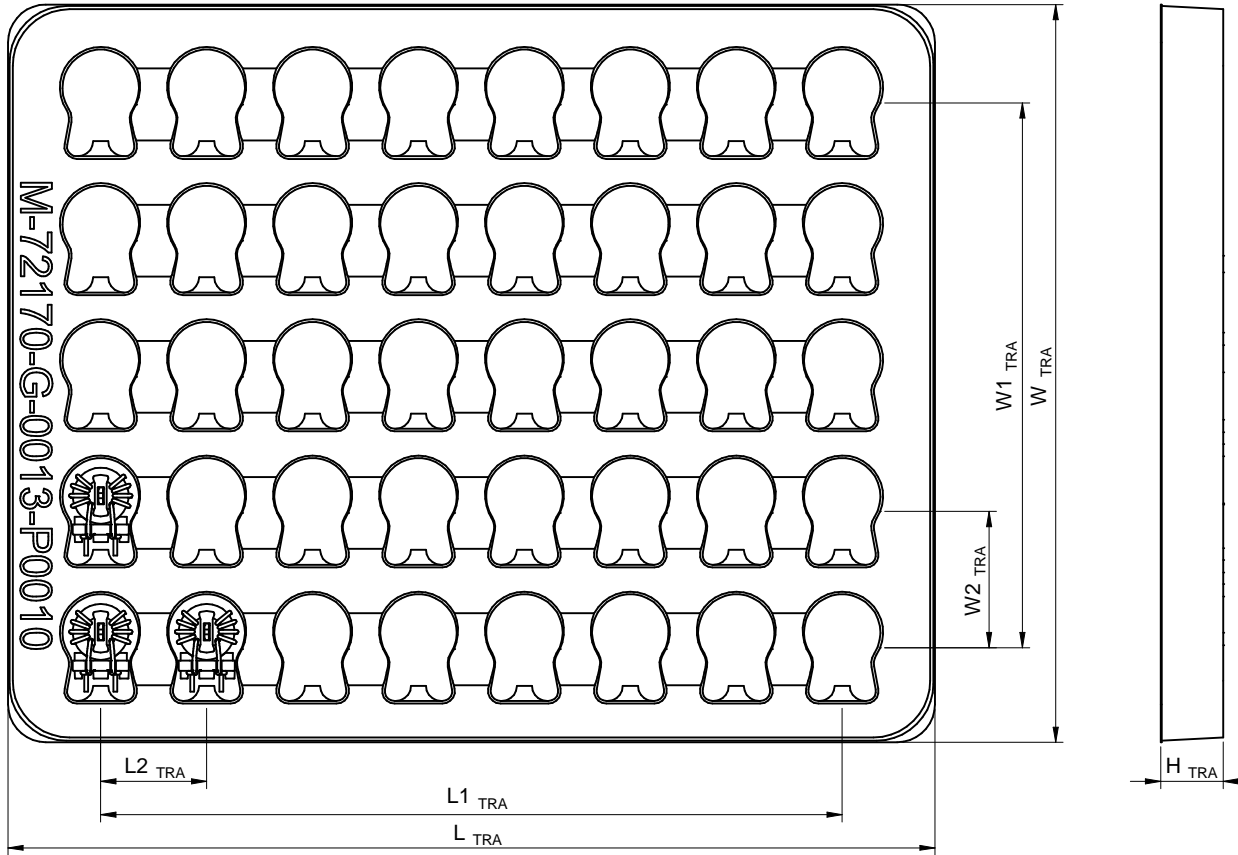



#### Packaging:


