
■ FREQUENCY CHARACTERISTICS

□INSERTION LOSS





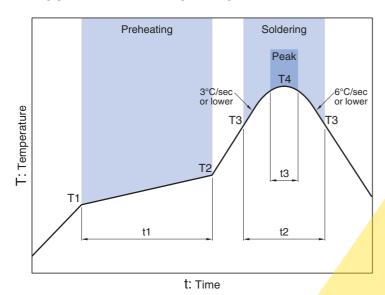

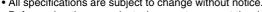
