


Figure 6. On-Resistance Variation with Temperature




I_D, DRAIN CURRENT (A) Figure 5. Typical On-Resistance vs. Drain Current

and Temperature












Figure 9. Diode Forward Voltage vs. Current




Figure 11. Gate Charge




Figure 8. Gate Threshold Variation vs. Temperature




Figure 10. Typical Junction Capacitance




Figure 12. SOA, Safe Operation Area







Figure 13. Transient Thermal Resistance







