




TO-220 CASE 221A PLASTIC




Figure 1. Typical Forward Voltage

Figure 2. Maximum Forward Voltage




Figure 3. Typical Reverse Current

Figure 4. Maximum Reverse Current




Figure 5. Current Derating




Figure 6. Forward Power Dissipation

Figure 7. Typical Capacitance




Figure 8. Thermal Response Junction-to-Ambient for MBR30L45CTG




Figure 9. Thermal Response Junction-to-Case for MBR30L45CTG




Figure 10. Thermal Response Junction-to-Case for MBRF30L45CTG




