








#### **TYPICAL CHARACTERISTIC CURVES**

**Fig.2 Typical Junction Capacitance** 




Fig.3 Typical Reverse Characteristics




Fig.4 Typical Forward Characteristics




Fig.5 Operating Temperature Derating Curve





