The Transient Voltage Suppressor offers a Working Peak Reverse Voltage from 5 V and Minimum Breakdown Voltage range of 6 V. The device can protect six unidirectional lines or five bidirectional lines,

available in a JEDEC SO-8 package and intended to be mounted directly onto an FR4 printed circuit board.












Peak Pulse Power vs Pulse Time




Pulse Waveform

Power Derating Curve





