

# AOZ8662BLT

Single Channel Bidirectional TVS Diode

## **General Description**

The AOZ8662BLT is a single channel transient voltage suppressor designed to protect high speed data lines and voltage sensitive electronics from high transient conditions and ESD.

The AOZ8662BLT comes in an RoHS compliant package and is rated over a -40°C to +125°C ambient temperature range.

The ultra-small  $0.43~\text{mm} \times 0.23~\text{mm}$  01005 footprint package makes the AOZ8662BLT ideal for applications where PCB space is a premium. The small size and high ESD protection makes it ideal for protecting voltage sensitive electronics from high transient conditions and ESD.






## **Typical Performance Characteristics**
