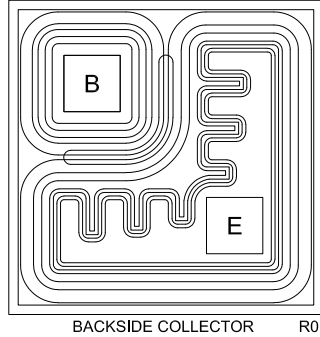


The CP101-BSS52 is a silicon NPN small signal Darlington transistor designed for industrial switching applications.

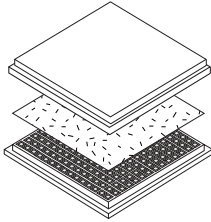

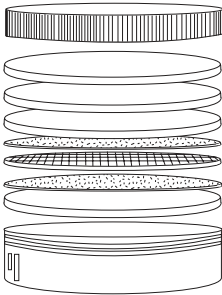


### BARE DIE IN TRAY (WAFFLE) PACK

(example: CP211-PART NUMBER-CM)

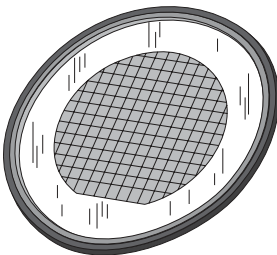

**WN:** Full wafer, unsawn, 100% tested with reject die inked.  
(example: CP211-PART NUMBER-WN)

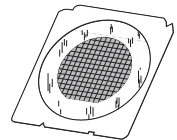

**WR:** Full wafer, sawn and mounted on plastic ring,  
100% tested with reject die inked.
