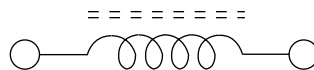

## Typical Percentage of Inductance vs. Current Curves

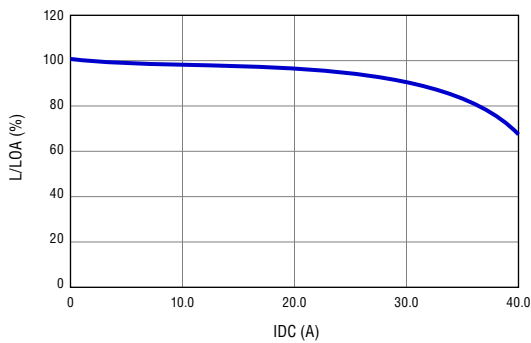

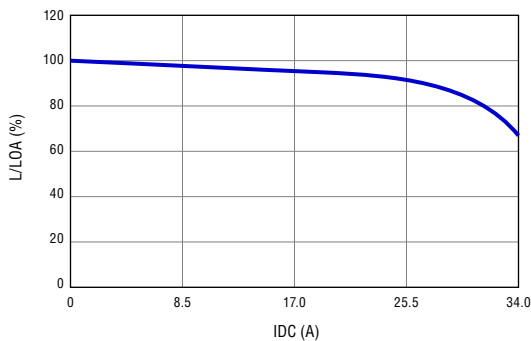

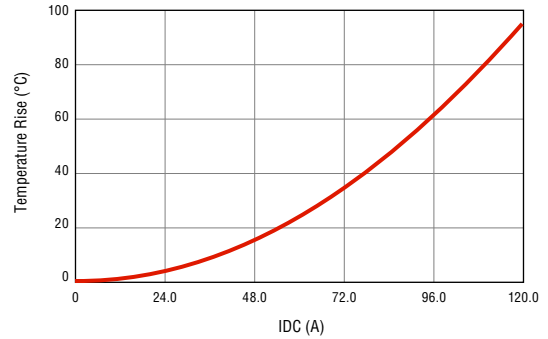

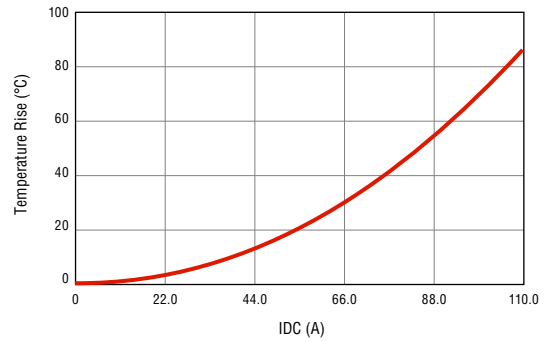


## Temperature Rise vs. Current Plots

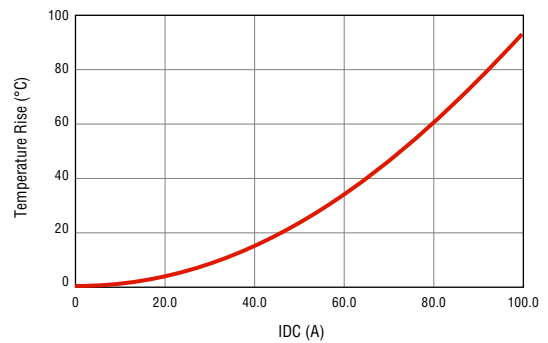
