




Fig 2. Typical Output Characteristics




Fig 5. Typical Capacitance vs. Drain-to-Source Voltage






Fig 7. Typical Source-Drain Diode Forward Voltage




Fig 9. Maximum Drain Current vs. Case Temperature






Fig 11. Maximum Effective Transient Thermal Impedance, Junction-to-Case




Fig 12a. Unclamped Inductive Test Circuit




Fig 12b. Unclamped Inductive Waveforms




Fig 13a. Basic Gate Charge Waveform




Fig 13b. Gate Charge Test Circuit www.irf.com




Fig 12c. Maximum Avalanche Energy vs. Drain Current




Fig 14. Threshold Voltage vs. Temperature






Fig 15. Typical Avalanche Current Vs.Pulsewidth





Fig 17. Peak Diode Recovery dv/dt Test Circuit for N-Channel HEXFET[®] Power MOSFETs









Fig 18b. Switching Time Waveforms


