






Figure 1. Typical Forward Voltage





Figure 2. Maximum Forward Voltage

Figure 4. Maximum Reverse Current




Figure 5. Current Derating





Figure 6. Forward Power Dissipation

Figure 7. Capacitance




Figure 8. Thermal Response Junction-to-Case for MBRF10H150CTG




