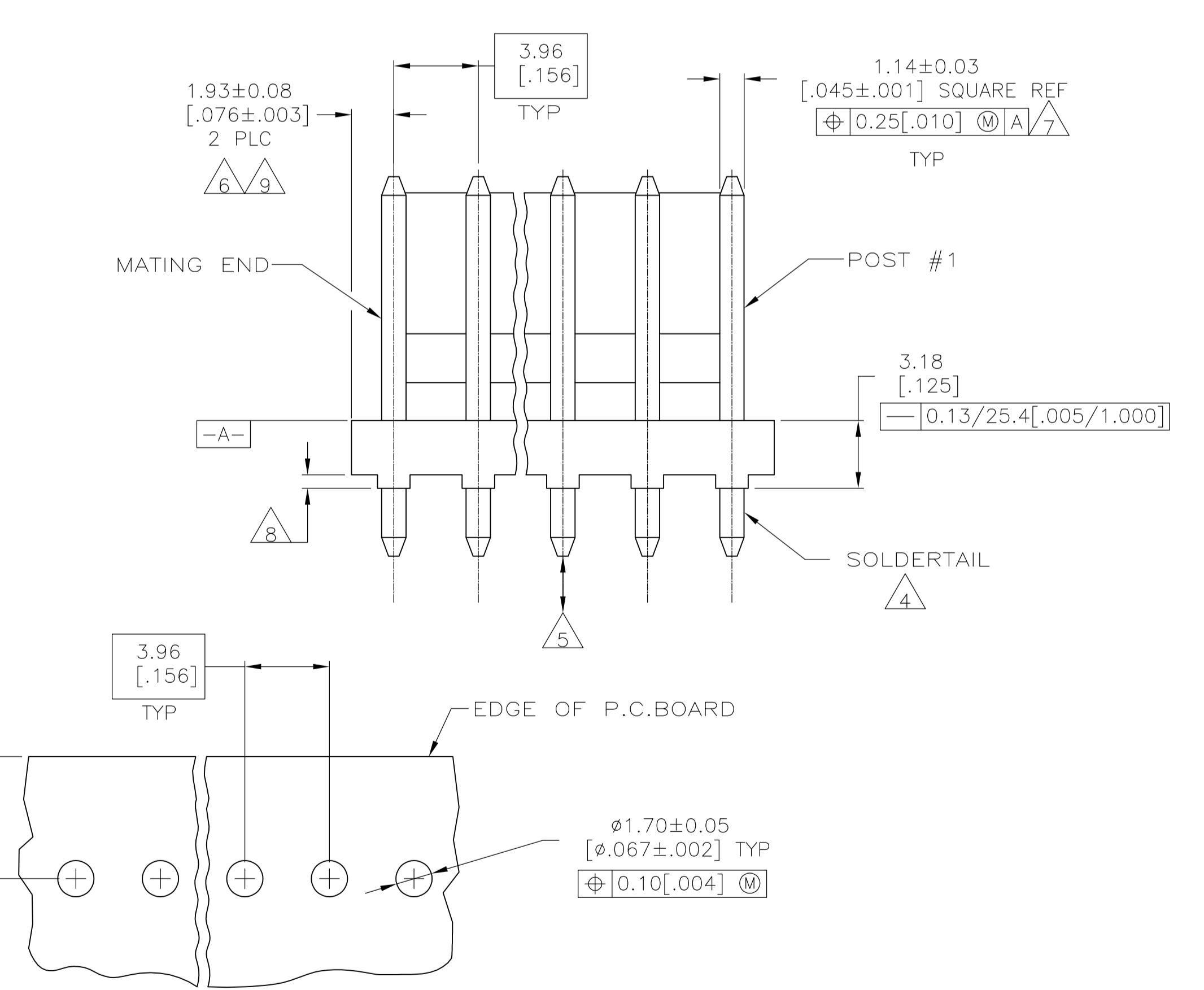
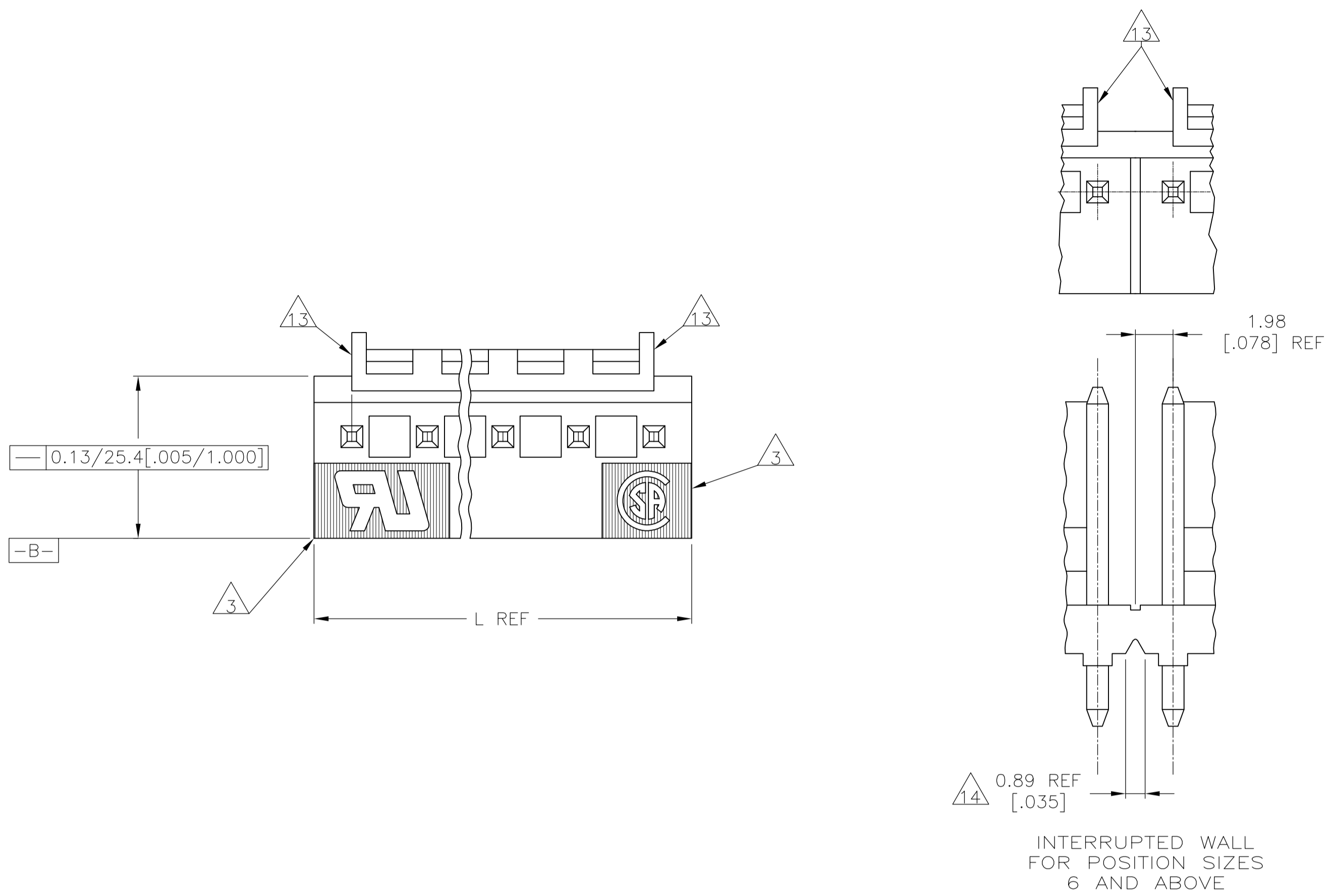

INTERRUPTED WALL FOR POSITION SIZES 6 AND ABOVE

- 1 MATERIAL HOUSING: THERMOPLASTIC POLYESTER, GLASS FILLED, UL94V-0. POST: COPPER ALLOY
- 2 FINISH HOUSING: NATURAL POST: BRIGHT TIN-LEAD (93/7) PLATE, 0.00380-0.00880[.000150-.000350] THK OVER NICKEL UNDERPLATE, 0.00130[.000050] MIN THK.
- 3 UL MARKING MAY NOT APPEAR ON THE 2 OR 3 POSITION SIZES. CSA MARKING MAY NOT APPEAR ON THE 2 POSITION SIZE.
- 4 POST SOLDERDETAILS COMPLY WITH AMP SOLDERABILITY SPEC 109-11-2.
- 5 POST WITHSTANDS 13.34N [3 LB] MIN AXIAL FORCE IN EITHER DIRECTION WITHOUT DISLODGING.
- 6 APPLIES AT -A-

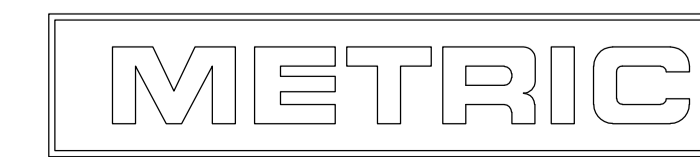
