TERMINAL LOCKING TANGS SHOULD BE FULLY SEATED IN HOUSING BEFORE ACTIVATING THE HINGED TPA



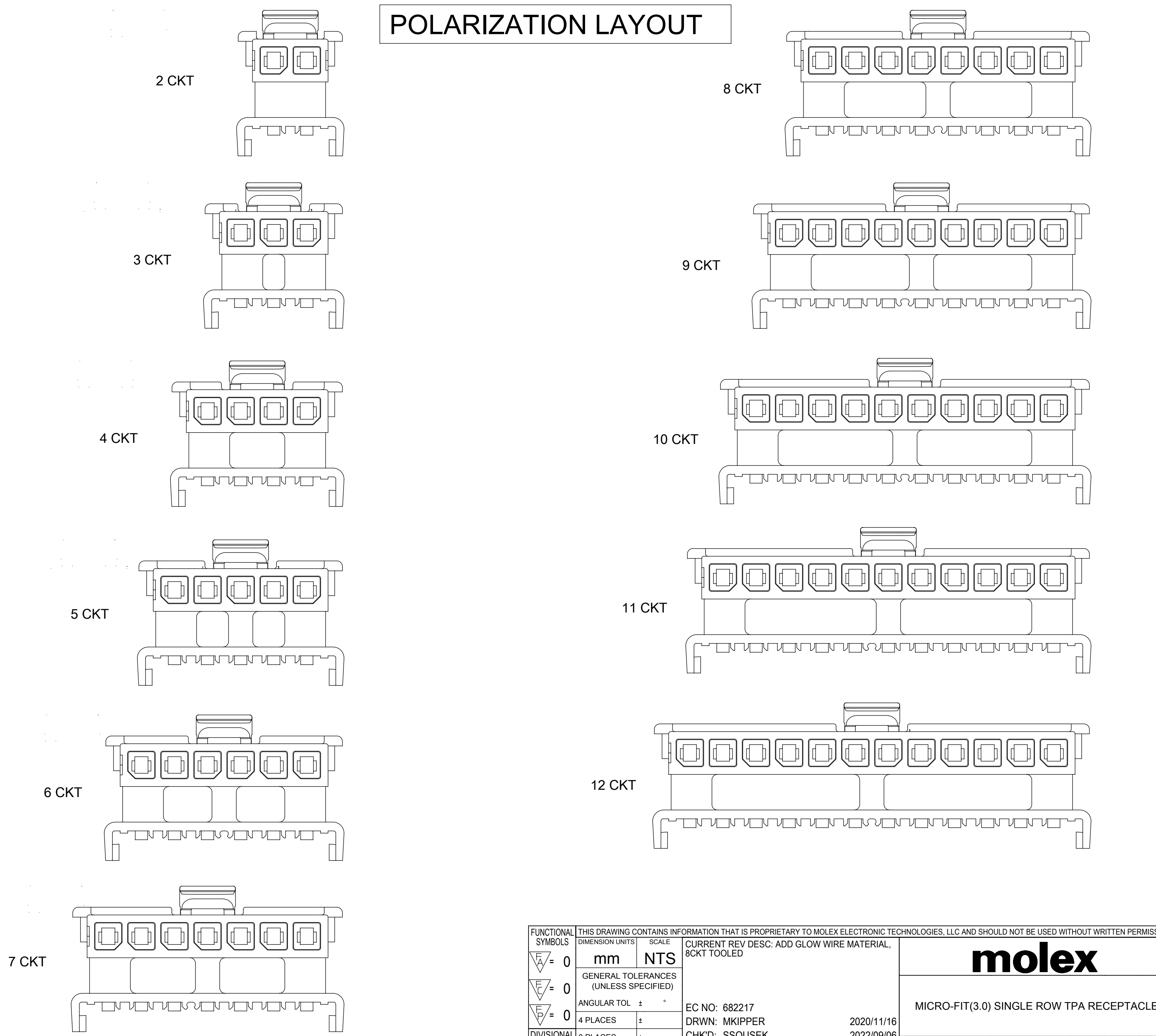
