



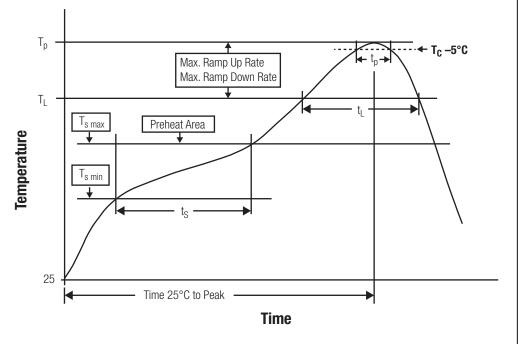

#### Soldering:
