




Relative CTR vs. Ambient Temperature:





Collector-Emitter Saturation Voltage vs. Ambient Temperature:




Forward Current vs. Forward Voltage:








Collector Current vs. Collector-Emitter Voltage:

Collector Current vs. Collector-Emitter Voltage, saturated





Absolute CTR vs. Forward Current (at $V_{CE}=5 V$)




Relative CTR vs. Forward Current (at $V_{CF}=5 V$)





Absolute CTR vs. Forward Current (at $V_{CE}=0.4 V$)




Relative CTR vs. Forward Current (at V_{CF}=0,4 V)





Switching time vs. Load Resistance:





Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk
- The soldering pad pattern shown above is a general recommendation for the easy assembly of optoelectronic components. If a high
 degree of precision is required for the selected application (i.e. high density assembly), the customer must ensure that the soldering pad
 pattern is optimized accordingly.

Cleaning and Washing:

Washing agents used during the production to clean the customer application might damage or change the characteristics of the

 shipment.




