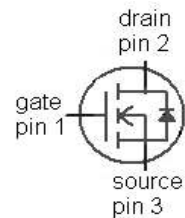

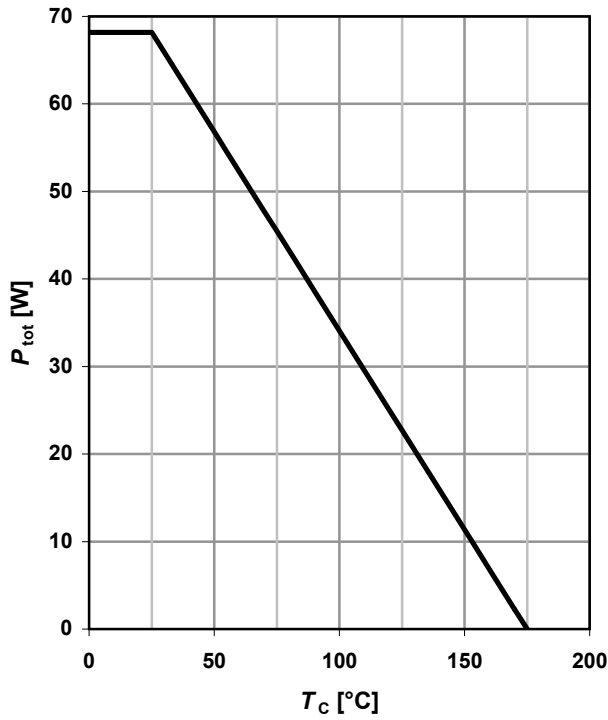

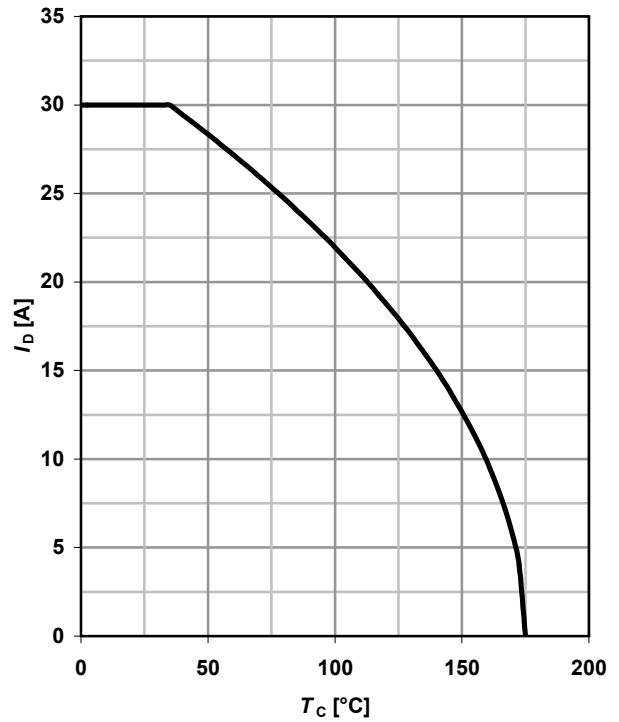
1 Power dissipation

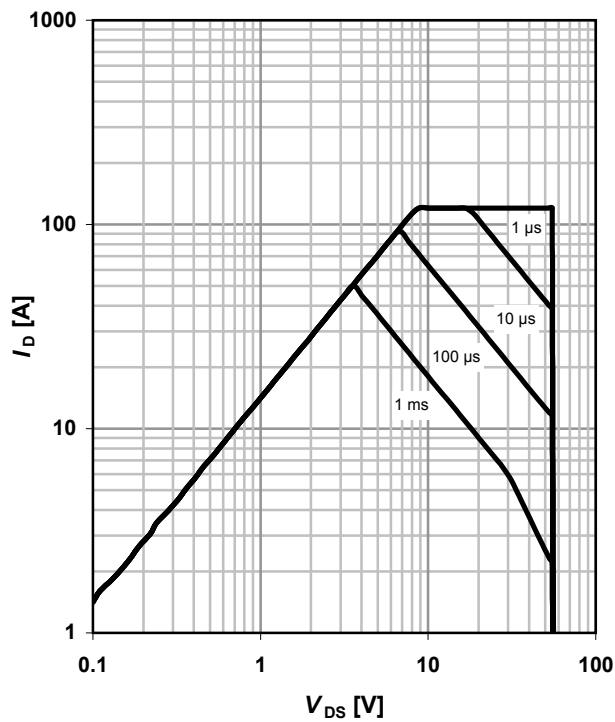

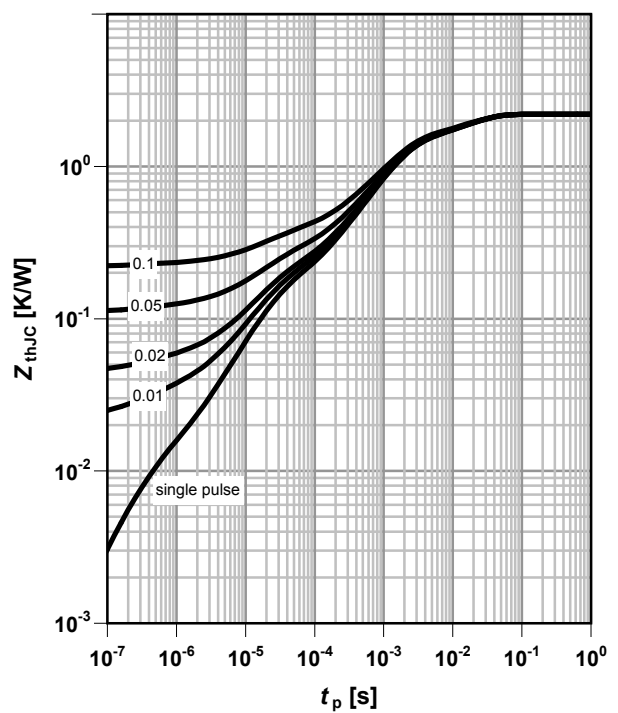

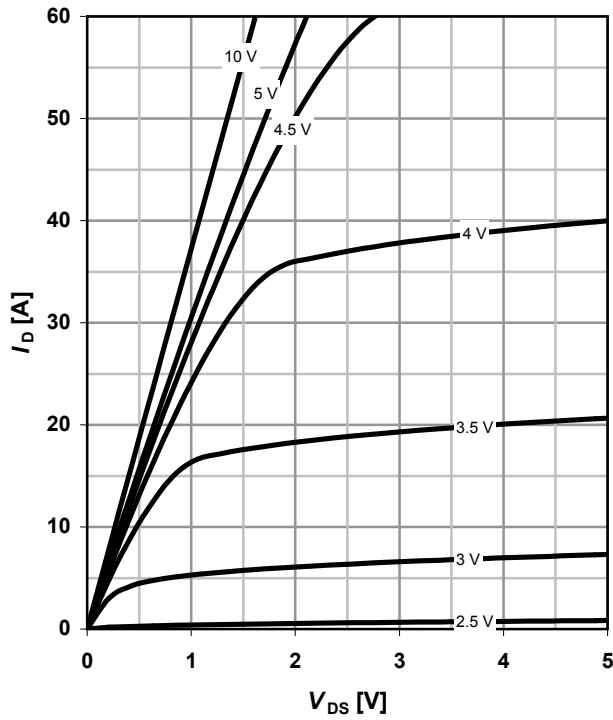

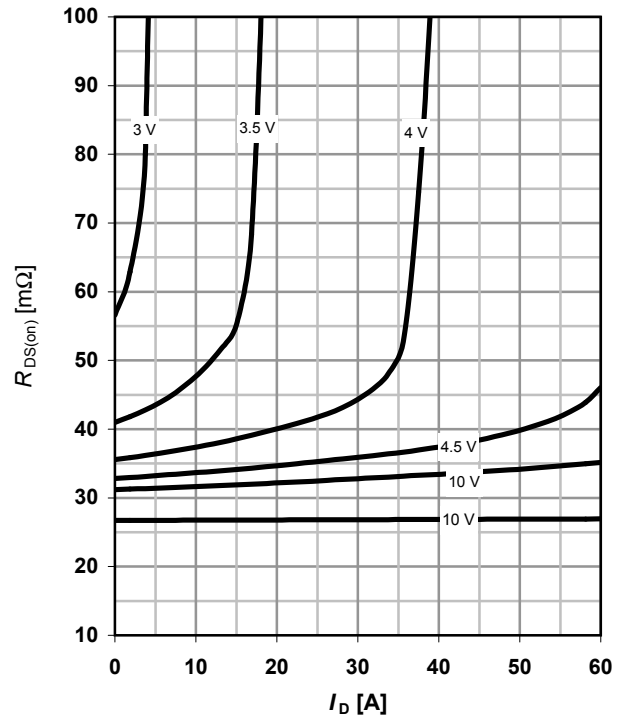

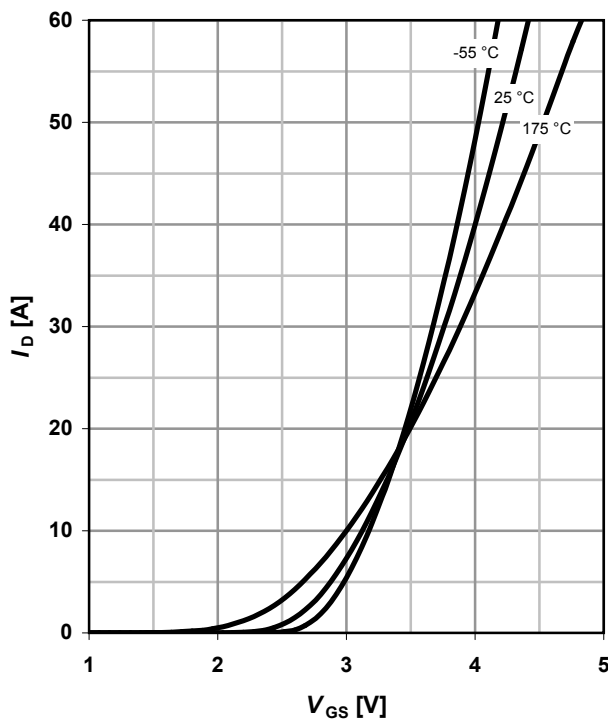

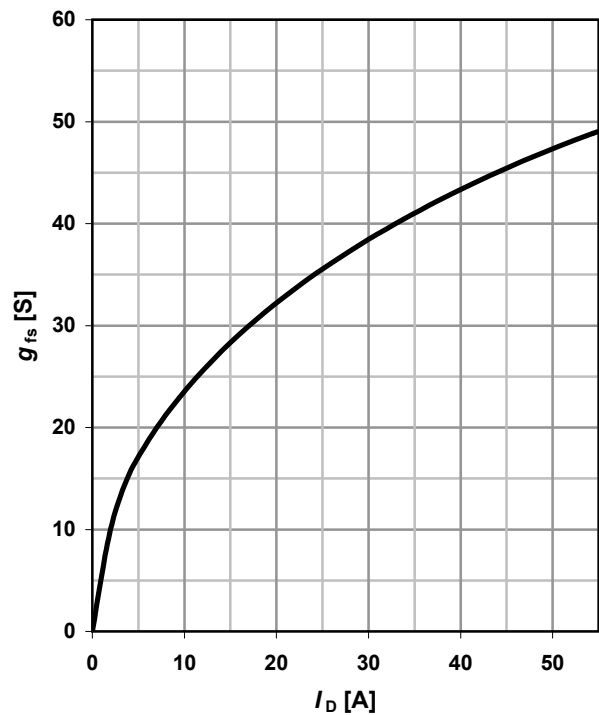

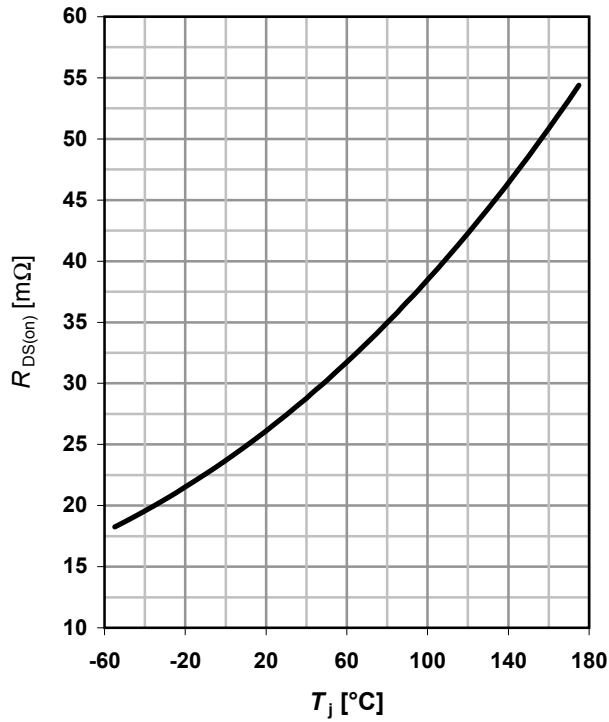

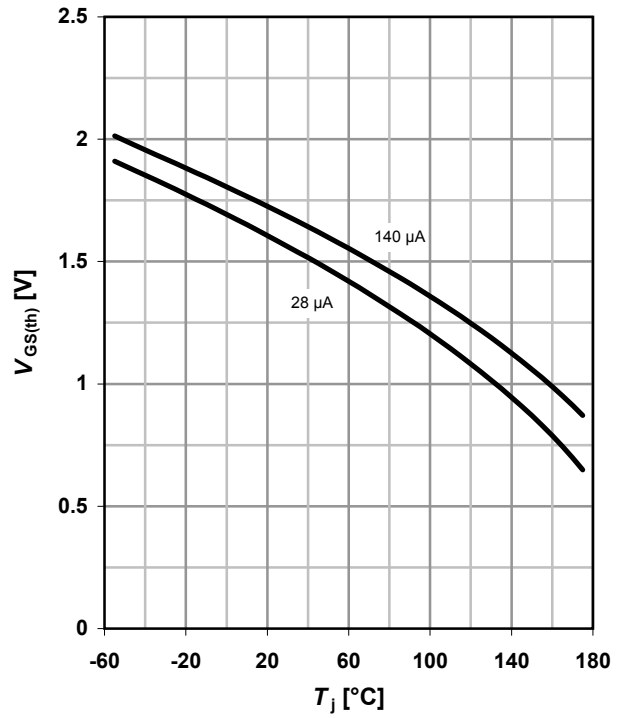

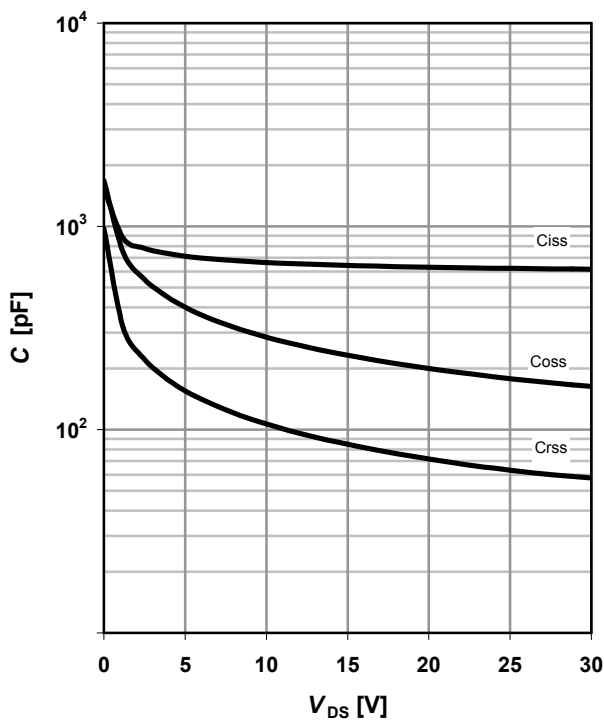

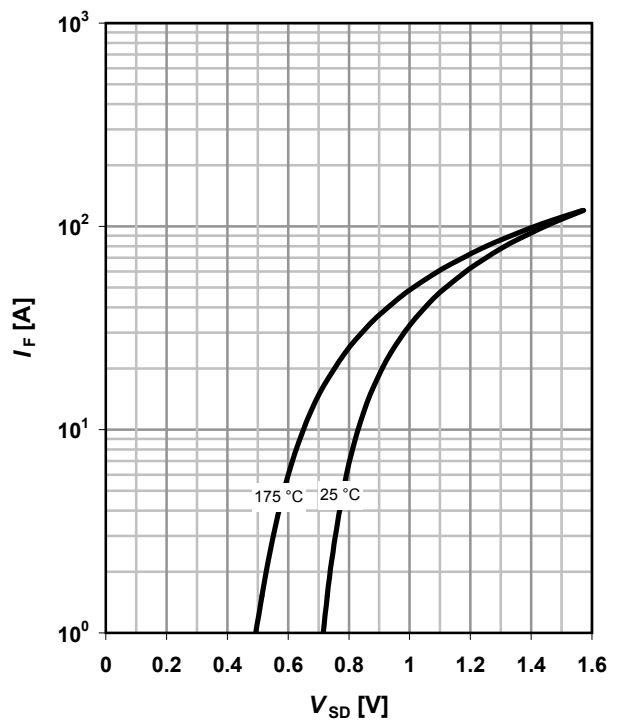

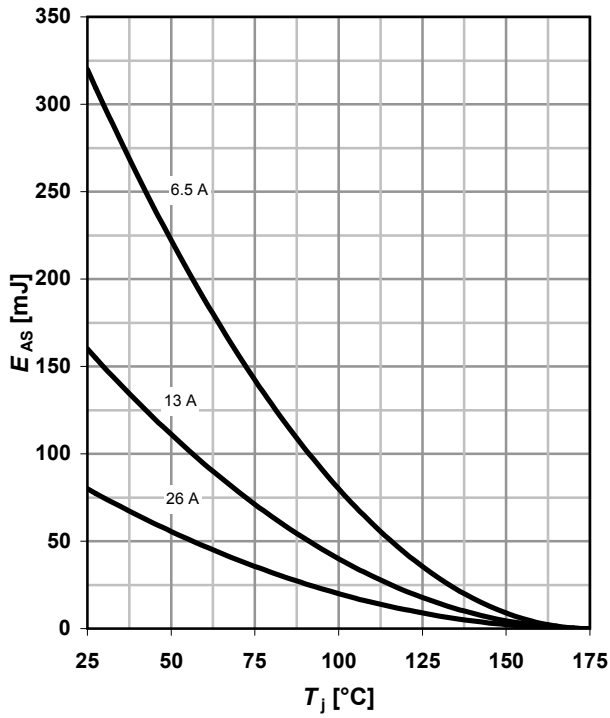

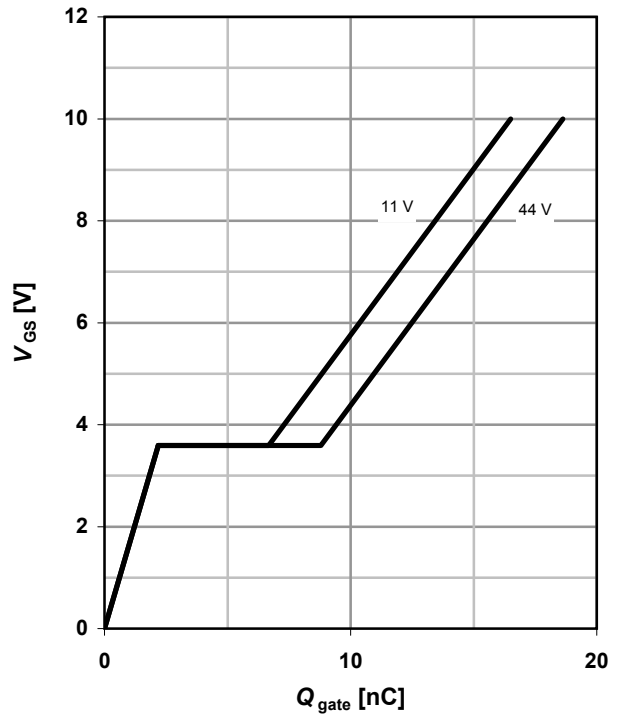

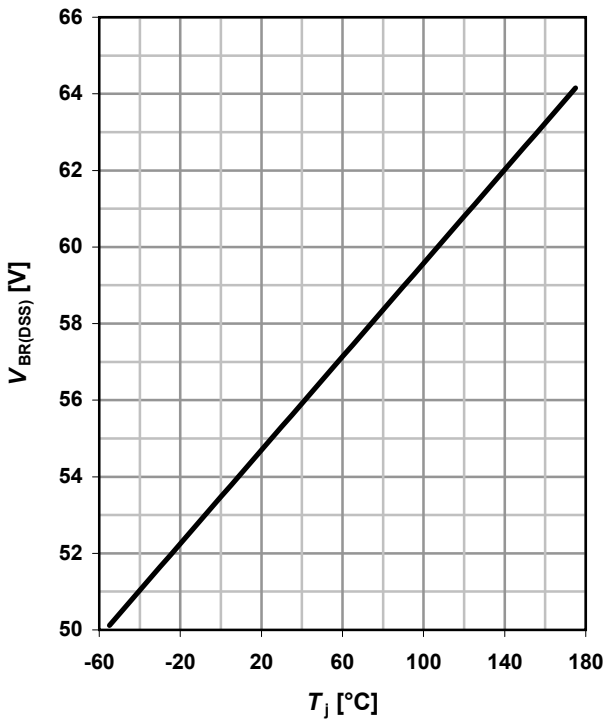
14 Typ. gate charge

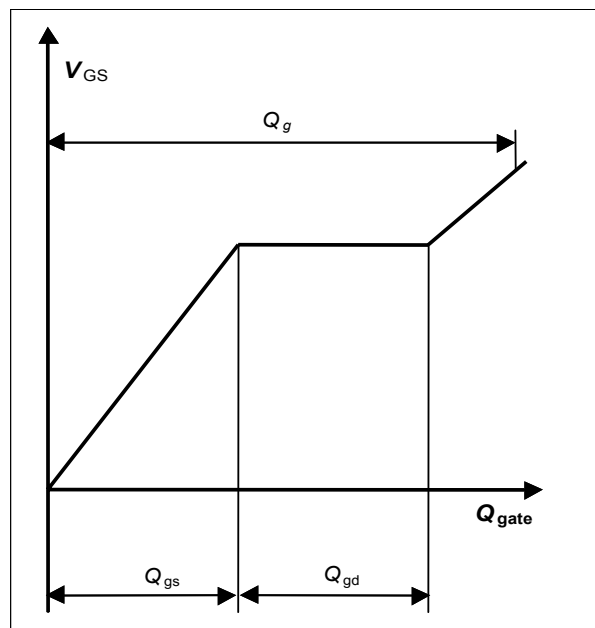


15 Typ. drain-source breakdown voltage
