



Fig.1 Grounded emitter propergation characteristics




Fig.2 Grounded emitter output characteristics




Fig.3 DC current gain vs. collector current





Fig.4 Collector-emitter saturation voltage vs. collector current

Fig.1 Grounded emitter propergation characteristics




Fig.2 Grounded emitter output characteristics




Fig.3 DC current gain vs. collector current






Fig.4 Collector-emitter saturation voltage vs. collector current




