### Typical Impedance Characteristics:

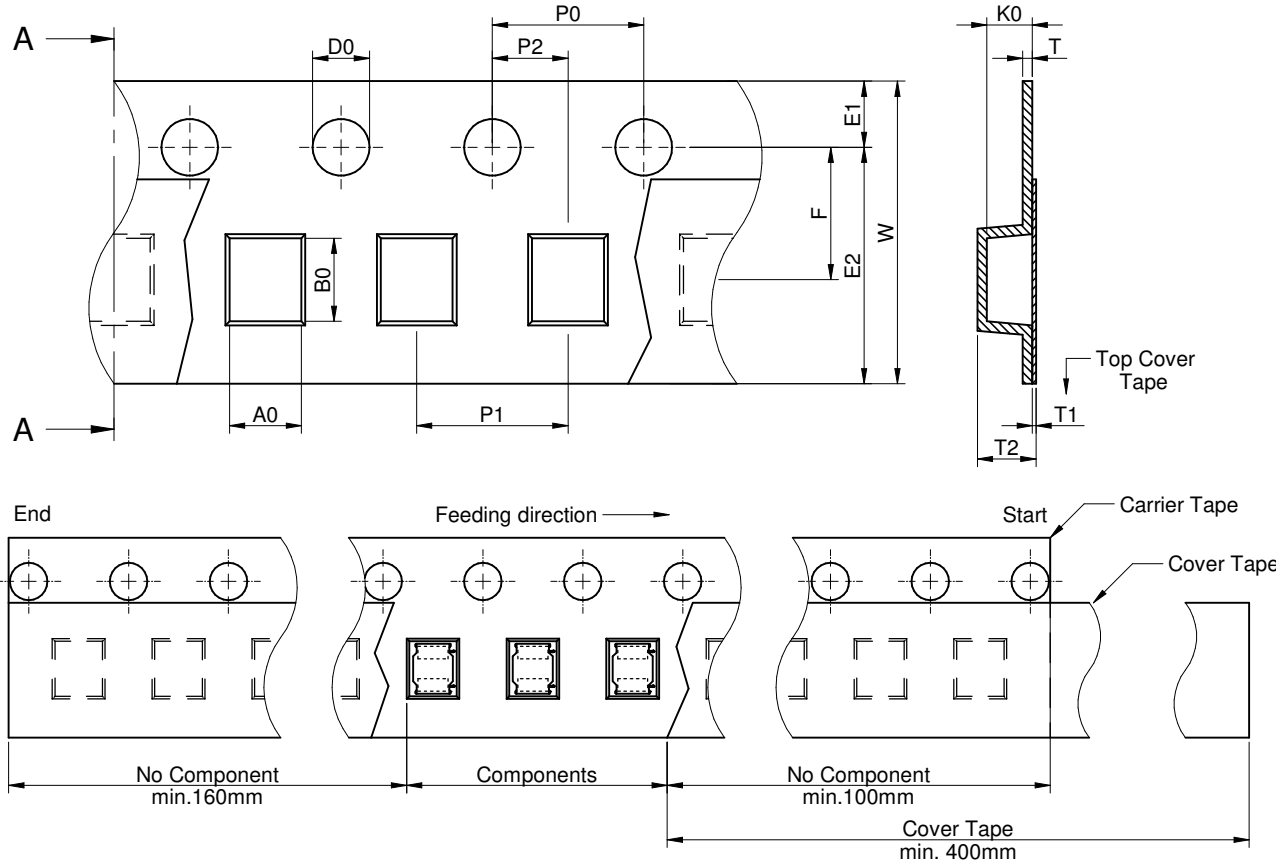

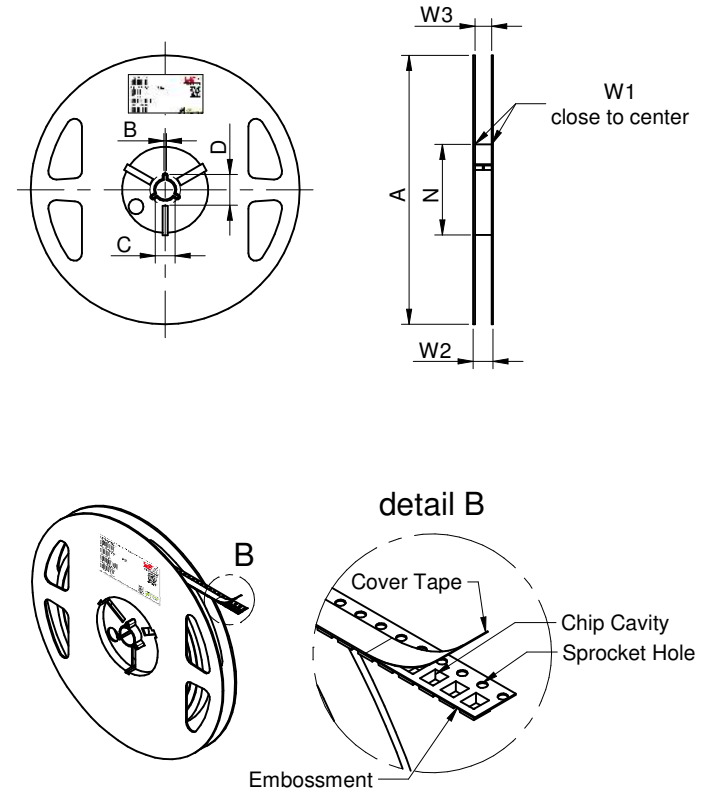

#### Soldering:



#### Packaging:


