### Q-Factor vs. Frequency:



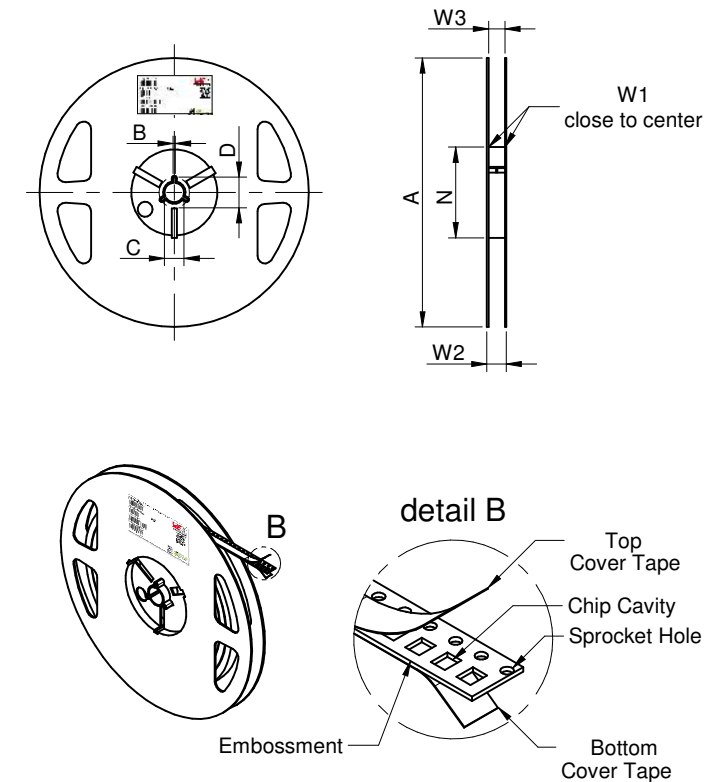

#### Soldering:



## Packaging:


