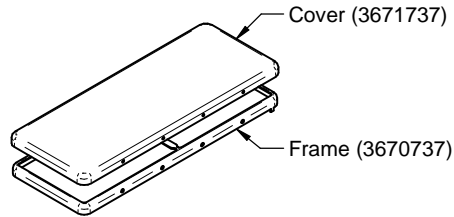


## Recommended Land Pattern: [mm]

#### Soldering:



#### Packaging:


