


#### **RELATIVE INTENSITY vs. WAVELENGTH**





#### **SPATIAL DISTRIBUTION**












#### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS





  3. Reflow soldering is recommended. Other soldering methods are not recommended as they might cause damage to the product.


