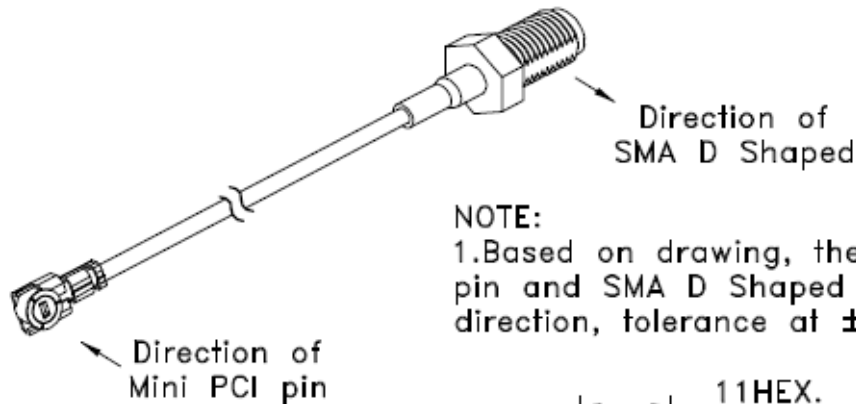

1. Based on drawing, the direction of Mini PCI pin and SMA D Shaped needed to be the same direction, tolerance at ± 45 degrees.

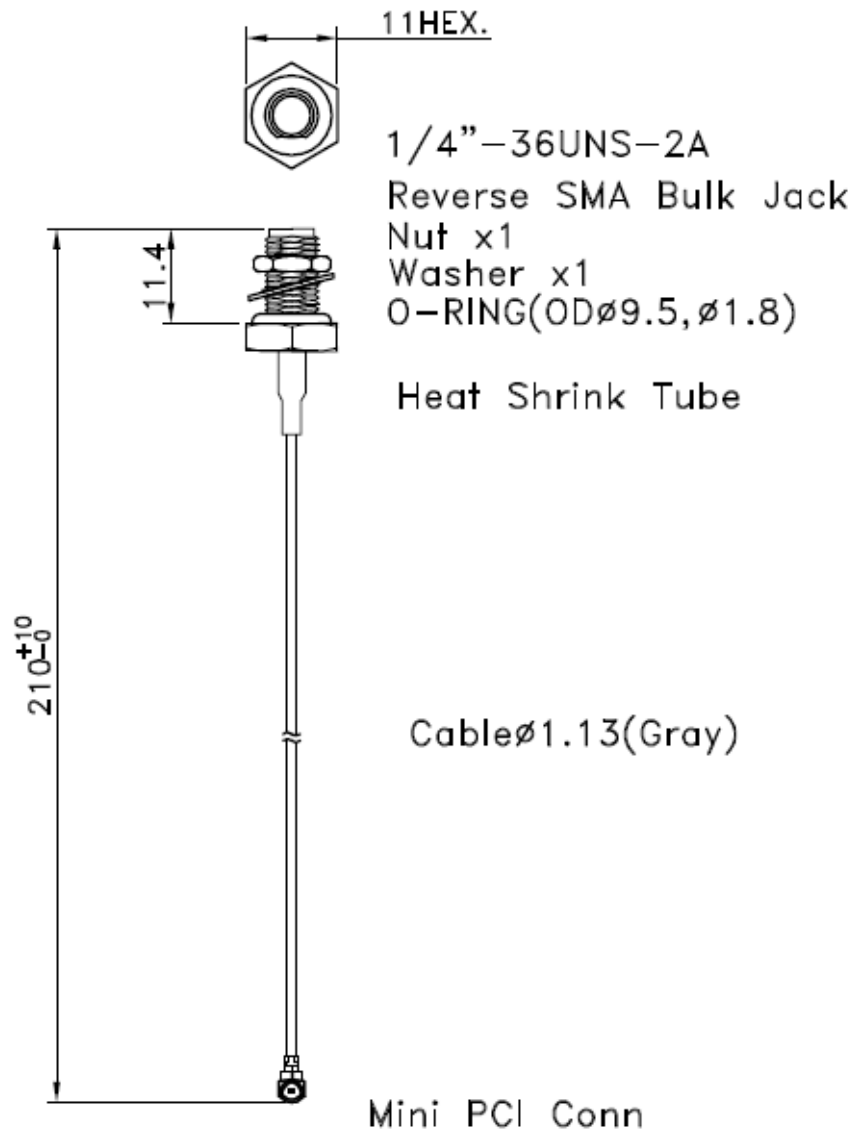


Figure 1 Physical Dimensions

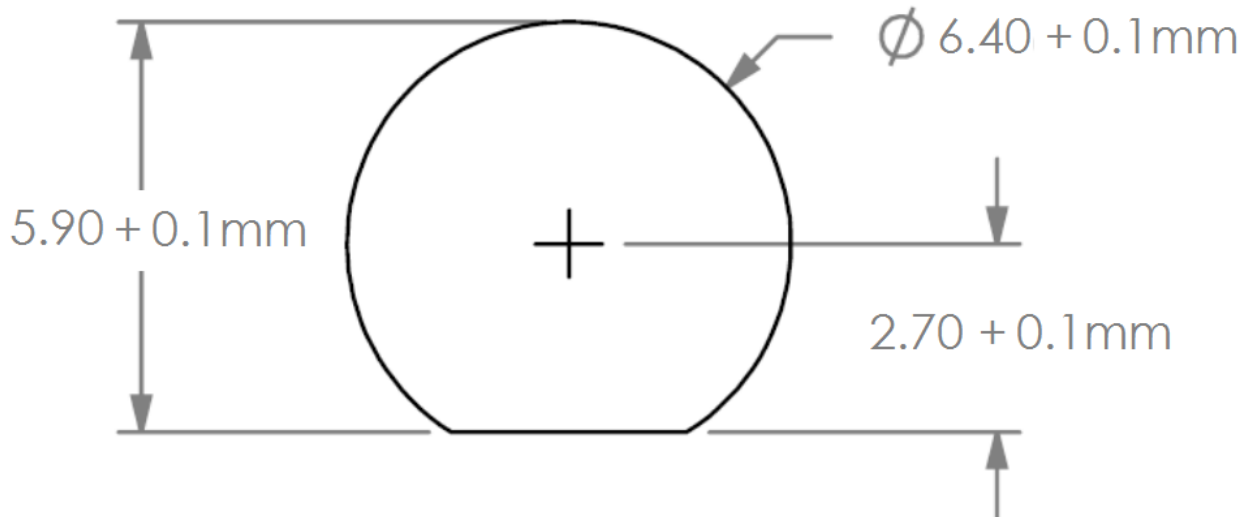


Figure 2 Recommend Cutout
