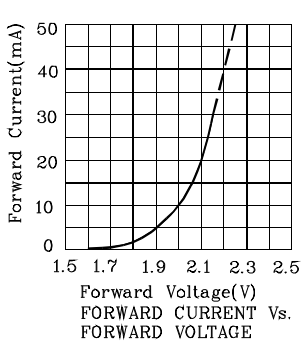


RELATIVE INTENSITY Vs. CIE WAVELENGTH

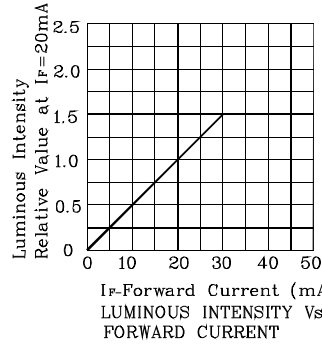

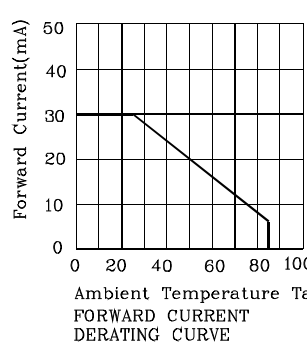

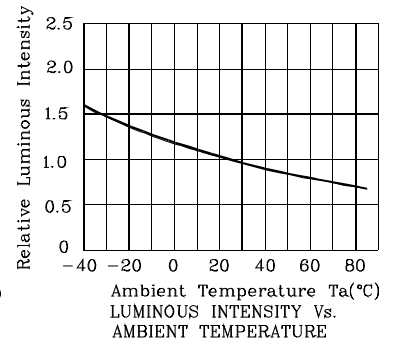
FORWARD CURRENT Vs. FORWARD VOLTAGE



LUMINOUS INTENSITY Vs. FORWARD CURRENT

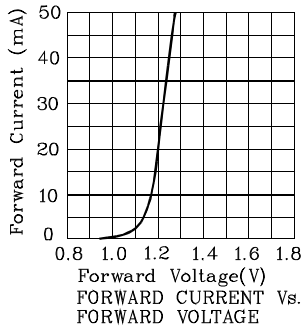


DERATING CURVE

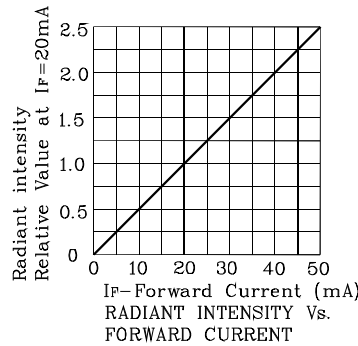


LUMINOUS INTENSITY Vs. AMBIENT TEMPERATURE

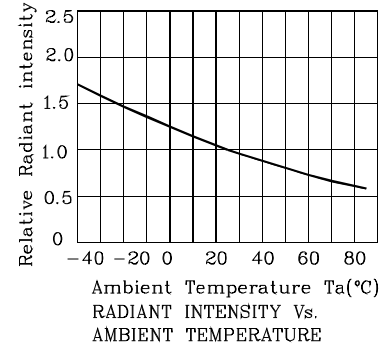

FORWARD CURRENT Vs. FORWARD VOLTAGE



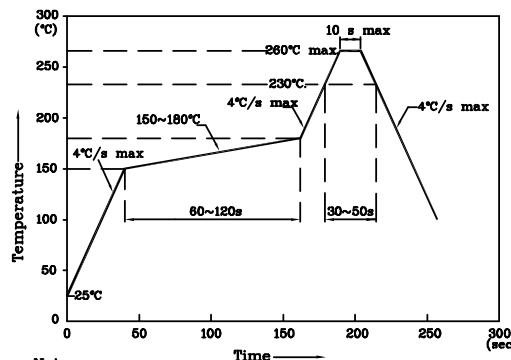
RADIANT INTENSITY Vs. FORWARD CURRENT

Reflow Soldering Profile for SMD Products (Pb-Free Components)

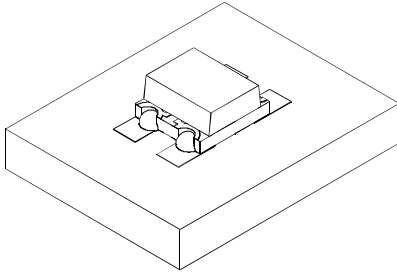


Notes:

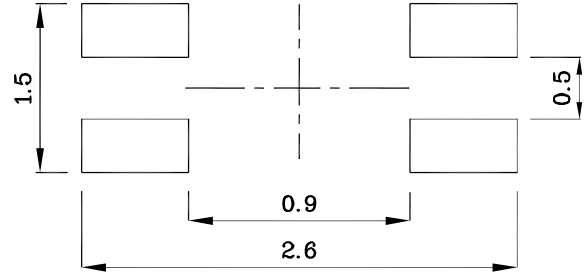
1. Maximum soldering temperature should not exceed 260°C
2. Recommended reflow temperature: 145°C-280°C
3. Do not put stress to the epoxy resin during high temperatures conditions



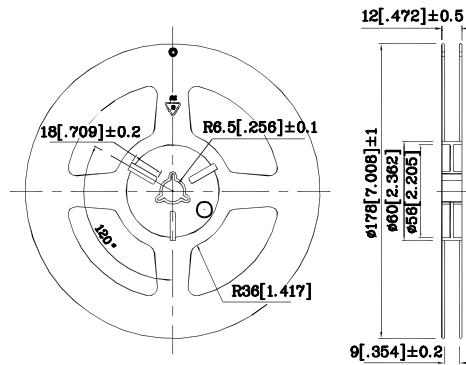

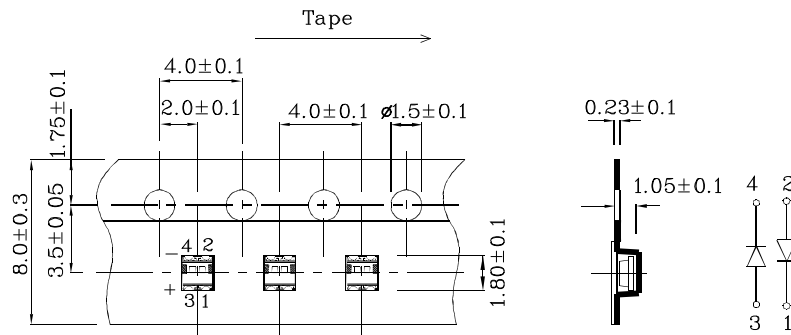
❖ Recommended Soldering Pattern

❖ Tape Specification (Units : mm)



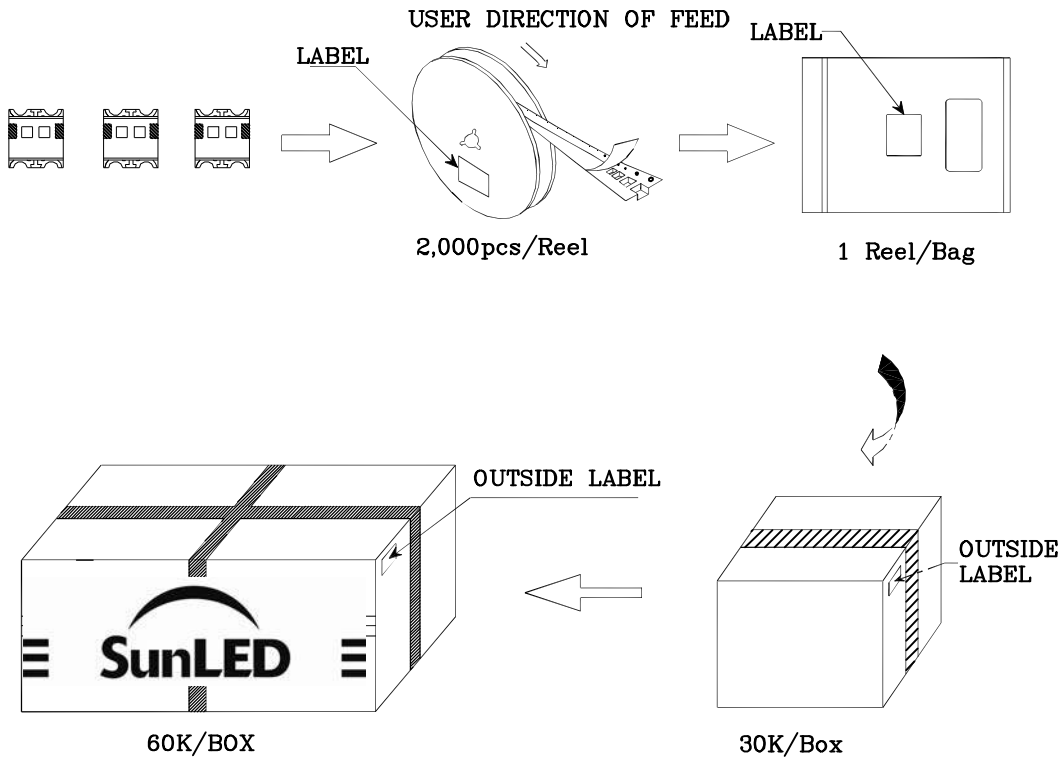
Remarks:


If special sorting is required (e.g. binning based on forward voltage, Luminous intensity / luminous flux, or wavelength), the typical accuracy of the sorting process is as follows:

1. Wavelength: $\pm 1\text{nm}$
2. Luminous intensity / luminous flux: $\pm 15\%$
3. Forward Voltage: $\pm 0.1\text{V}$

Note: Accuracy may depend on the sorting parameters.
