
### □INSERTION LOSS

#### □RETURN LOSS

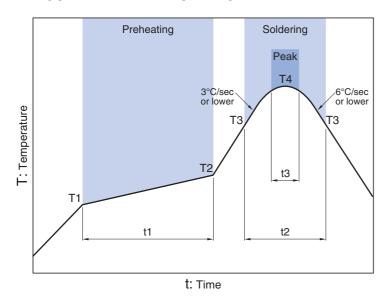
