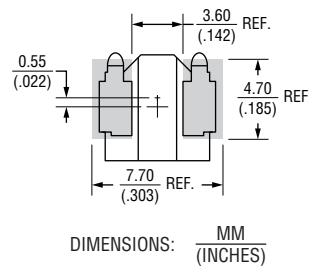

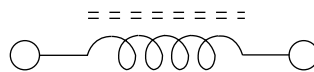

Soldering Profile

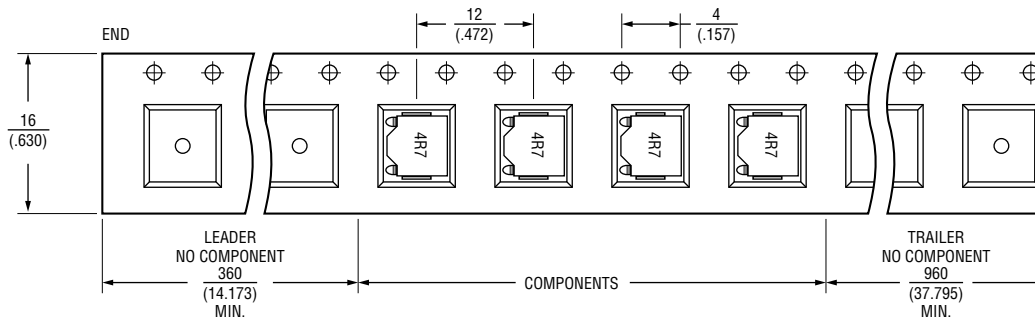
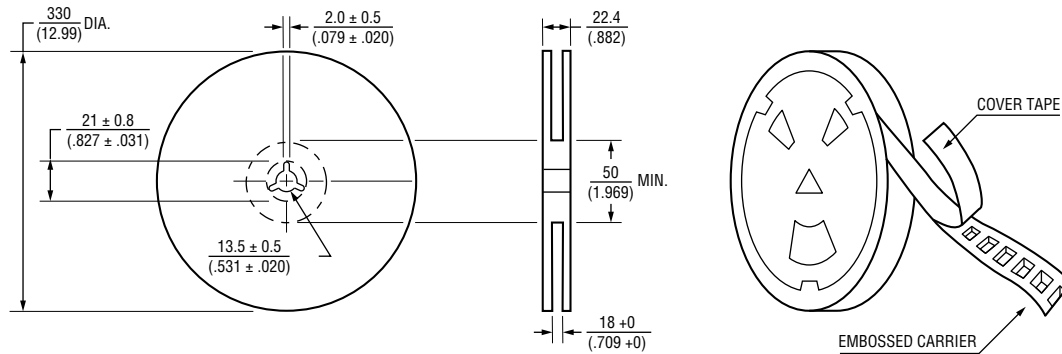
