### Typical Attenuation:



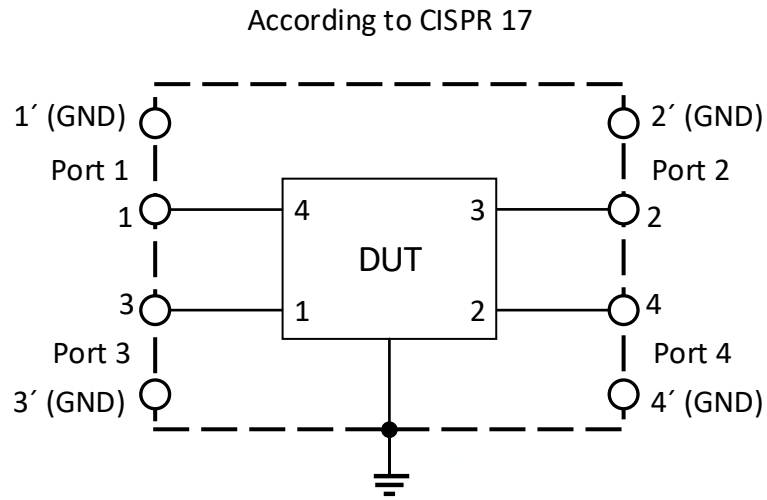

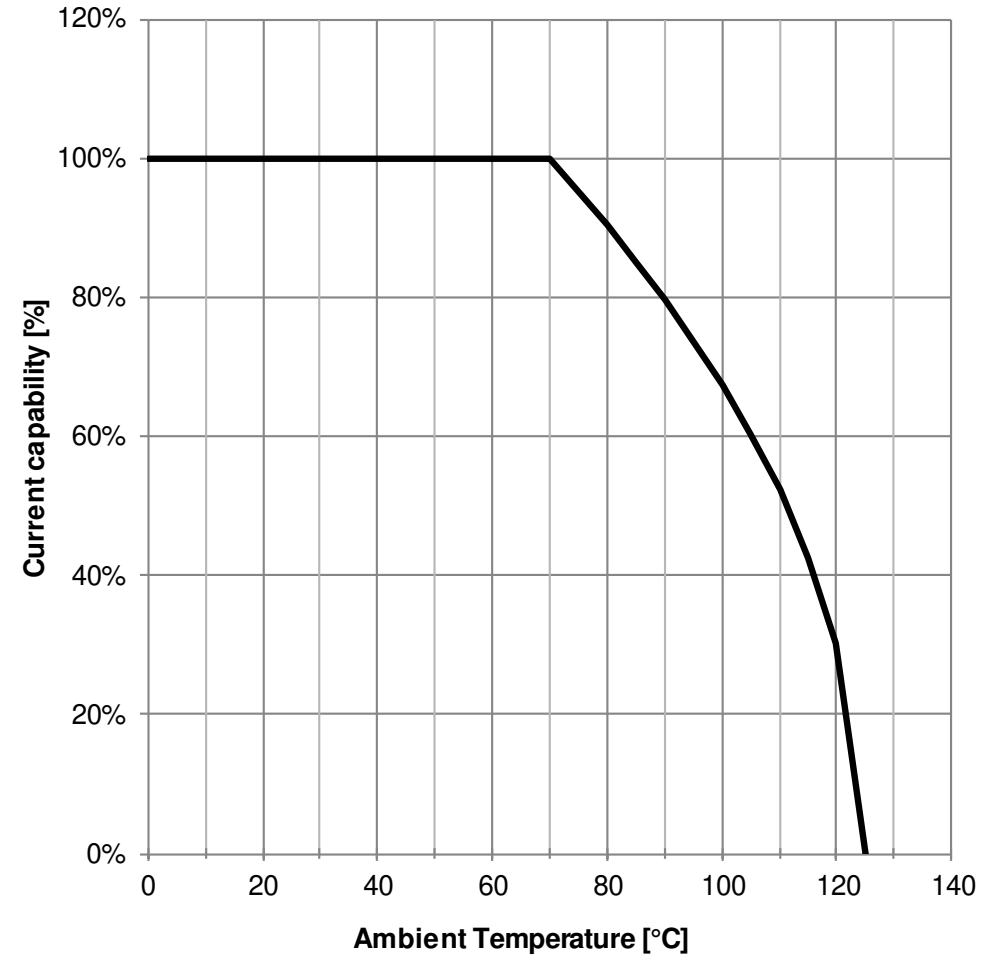



## Storage Conditions:


